Beauty AFFAIR DROP AD REQUIREMENTS

A **DROP AD** is a completed graphic you submit according to Beauty Affair's specifications. We **"DROP"** your graphic directly into the magazine. These guidelines protect the reader's visual experience and help your ad perform at its best.

WHY THESE STANDARDS MATTER

When readers flip through the magazine, the visual flow drives engagement.

Text-heavy layouts pull the eye away from your message. Clean design keeps the reader focused on your brand. These standards protect both the aesthetic of the magazine and the visibility of your ad.

VISUAL REQUIREMENTS

Minimum 2/3 Graphic Coverage

Your design must cover at least two-thirds of the ad space with imagery or visual elements.

Allowed Text Surface Area

Any text block may not exceed 1/4 of the total ad surface area, regardless of ad size.

No Advertorial Layouts

Drop ads cannot mimic an article. No paragraph-style storytelling, Q&A formatting, or anything that resembles editorial content.

TEXT MAXIMUMS BY AD SIZE

To keep your ad visually compelling, descriptions must stay within these limits: Maximum word count in one text block
