Approximately 2,000 U.S. troops have been ordered to be ready to deploy in response to the escalating conflict between Israel and the Palestinian militant group Hamas, Pentagon officials announced Tuesday.

The "prepare to deploy" order by Defense Secretary Lloyd Austin "increases DoD's ability to respond quickly to the evolving security environment in the Middle East," Pentagon Deputy Press Secretary Sabrina Singh said in a release Tuesday. "No decisions have been made to deploy any forces at this time. The Secretary will continue to assess our force posture and remain in close contact with allies and partners."

This move to increase the "increases DoD's ability to respond quickly to the evolving security environment in the Middle East" by readying US troops along with deploying destroyer ships in the area is in my opinion a bad move due to the propaganda on both sides. This conflict should be brought to a peaceful halt, but with the brinksmanship game being played between the western alliances and the Middle Eastern nations, and with both sides looking to claim the moral high ground, potential for a crisis is high. TAIPEI, Oct 19 (Reuters) - Taiwan's defence ministry said that it had detected 13 Chinese air force planes entering Taiwan's air defence zone on Thursday morning,

including fighter jets and drones, accompanying Chinese warships carrying out "combat patrols" and drills.

Taiwan, which China claims as its own territory, has repeatedly complained over the past four years of Chinese military activity around the island.

BEIJING, Oct 18 (Reuters) - Russian President Vladimir Putin said on Wednesday that the United States was wading deeper into the Ukraine conflict and making a mistake by providing Kyiv with long-range ATACMS missiles.

He told a news conference during a visit to China that he had briefed President Xi Jinping "in some detail" about Ukraine. He said "external factors" and "common threats" served only to strengthen Russia-Chinese cooperation.

The Kremlin chief said Washington's decision to supply the Army Tactical Missile System (ATACMS), whose use Kyiv confirmed on Tuesday, "just prolongs the agony" for Ukraine.

"Firstly, this of course causes harm and creates an additional threat. Secondly, we will of course be able to repel these attacks. War is war," Putin said.

"But most importantly, it fundamentally lacks the capacity to change the situation on the line of contact at all ... This is another mistake by the United States."

TEL AVIV — The U.S. has assessed that the deadly blast at a Gaza hospital Tuesday was most likely caused by a misfired rocket from Palestinian Islamic Jihad,

according to two U.S. officials and a congressional staffer. The group has been designated a terrorist organization by the U.S.

NBC News consulted four military and munitions experts. One agreed with the U.S. assessment, which President Joe Biden hinted at during his trip to Israel on Wednesday. Three agreed the blast wasn't from Israel. The experts were shown parts of more than a dozen videos and pictures from the incident at al-Ahli Baptist Hospital and its aftermath that have been geolocated and analyzed by NBC News; some said the marks left by the projectile aren't consistent with the weaponry Israel has used recently.



This attack which was originally reported to have hit the hospital is now said to have hit the parking lot where many displaced by the bombings were seeking safety. This is being used as a false flag by Hamas who claims this was an Israeli missile to gain support, taking advantage of the death of their own people. It also seems that Israel could have intentionally done this, due to their leaders calling for the Gaza strip to be leveled. The white house has had to walk back statements on who's rocket it was, which is why I believe we should remain neutral until intelligence discovers and locates who is responsible, and a justifiable action can be carried out.

During his Tel Aviv visit on Wednesday, President Biden had been pressed by reporters as to what convinced him to side with Israel's denial that it didn't strike Al-Ahli Baptist Hospital in Gaza, killing up to 200-300 people, according to local health officials. Biden had said that data from his Defense Department showed the explosion was unlikely to have been an Israeli airstrike. But it's not just journalists that want more, US lawmakers are also demanding clearer answers.

A group of Progressive Democrats in Congress are now pushing the Biden White House to publicly declassify the intelligence that the US has on the hospital bombing.

According to Haaretz, "Administration officials provided senators with a classified briefing on Wednesday, shortly after the ranking bipartisan members of both the House and Senate Intelligence Committees said they reviewed information and reached the same conclusion."

Thirteen Democrats have brought the two-page resolution which additionally presses Biden to "immediately call for and facilitate de-escalation and a ceasefire to urgently end the current violence" as well as to "promptly send and facilitate the entry of humanitarian assistance into Gaza." The US voted down a UN Security Council resolution this week which called for a humanitarian ceasefire.

Chicago is giving \$9,000 in rental assistance to migrants in need of temporary housing - after it paid a medical firm a staggering \$7.2million for staffing shelters for just one week, according to official records.

The Windy City is struggling with over 11,000 migrants in shelters and 4,000 staying in police stations and the O'Hare International Airport after more than 18,000 have arrived in the city in one year.

To free much-needed room in shelters, the state of Illinois is helping cover costs for temporary housing for migrants, including \$9,000 in rental assistance over a six-month period, Chicago's deputy chief of staff Cristina Pacione-Zayas told Fox32. The funds include assistance with moving costs and a starter kit to furnish apartments.

What we are seeing with both of the articles is the response to the migrant crisis being paid for with tax payer money.

Both cities are being overwhelmed with "migrants" and are struggling to control the resistance of the people, while providing for large numbers of non-citizens who will have every aspect of their life subsidized or go homeless and hungry.

New York City officials are limiting the time asylum-seekers with children can spend in the city's shelter system.

Starting next week, city officials will begin notifying some families that they have 60 days to find alternative housing. Last month, NYC Mayor Eric Adams' administration announced it would be handing out 30-day notices for adult migrants without children.

The move to restrict the amount of time in the shelter system comes as the city continues to grapple with a large number of asylum-seekers coming to the city since spring of last year. Over 126,000 asylum-seekers have moved through the shelter system so far since Spring 2022.

"For over a year, New York City has led the response to this national crisis, but significant additional resources, coordination, and support are needed from all levels of government. With over 64,100 asylum seekers still in the city's care, and thousands more migrants arriving every week, expanding this policy to all asylum-seekers in our care is the only way to help migrants take the next steps on their journeys," Mayor Adams said in a statement Monday.

Defendant Unlawfully Used Social Media to Deprive Individuals of Their Right to Vote

A Florida man was arrested this morning on charges of conspiring with others in advance of the 2016 U.S. Presidential Election to use various social media platforms to disseminate misinformation designed to deprive individuals of their constitutional right to vote.

Douglass Mackey, aka Ricky Vaughn, 31, of West Palm Beach, was charged by criminal complaint in the Eastern District of New York. He was taken into custody this morning in West Palm Beach and made his initial appearance before U.S. Magistrate Judge Bruce E. Reinhart of the Southern District of Florida.

"According to the allegations in the complaint, the defendant exploited a social media platform to infringe one the of most basic and sacred rights guaranteed by the Constitution: the right to vote," said Nicholas L. McQuaid, Acting Assistant

Attorney General of the Justice Department's Criminal Division. "This complaint underscores the department's commitment to investigating and prosecuting those who would undermine citizens' voting rights."

"There is no place in public discourse for lies and misinformation to defraud citizens of their right to vote," said Seth D. DuCharme, Acting U.S. Attorney for the Eastern District of New York. "With Mackey's arrest, we serve notice that those who would subvert the democratic process in this manner cannot rely on the cloak of Internet anonymity to evade responsibility for their crimes. They will be investigated, caught and prosecuted to the full extent of the law."

WASHINGTON — A host of the far-right media outlet Infowars was sentenced Tuesday to 60 days in prison for his role in the Jan. 6 attack on the U.S. Capitol.

Owen Shroyer is one of only a handful of Jan. 6 participants charged with a crime despite having neither entered the Capitol building nor been accused of committing violence or destruction on Capitol grounds. Prosecutors charged Shroyer because he had previously signed a deferred prosecution agreement after he interrupted a congressional hearing in 2019 and had agreed as part of that case not to utter "loud, threatening, or abusive language, or to engage in any disorderly or disruptive conduct, at any place upon the United States Capitol Grounds."

(KRON) — The president of a Silicon Valley-based medical technology company was sentenced on Wednesday to eight years in prison and ordered to pay \$24 million in restitution for using a global pandemic to fuel a "massive fraud," according to the U.S. Attorney's Office.

Mark Schena, 60, of Los Altos, used his company, Arrayit Corporation, to defraud investors and submit \$77 million in claims for COVID-19 and allergy testing, prosecutors said. A federal jury convicted Schena on Sept. 6, 2022 in San Jose.

"Schena engaged in a scheme to defraud Arrayit's investors by claiming that he had invented a revolutionary technology to test for virtually any disease using a single drop of blood from a finger stick sample," federal prosecutors wrote.

Schena's fraud scheme mirrors a similar fraud made by disgraced Theranos founder Elizabeth Holmes. Holmes, who was convicted of fraud and is currently in federal prison, was a rising star in Silicon Valley when she claimed Theranos' blood testing technology could work with just a few drops of blood.

In meetings with investors, Schena and his publicist claimed that Schena was the "father of microarray technology" and that he was on the shortlist for the Nobel Prize, according to the U.S. Attorney's Office. Schena also falsely represented to investors that Arrayit could be valued at \$4.5 billion. But like Theranos, Arrayit was on the verge of bankruptcy.

"Schena put profit over public safety. He used the global pandemic as a backdrop to fuel a kickback scheme and a massive fraud upon investors and people searching for better health care during a time of great uncertainty," said U.S. Attorney for the Northern District of California Ismail Ramsey.
