WARRANTY: Your unit has a limited warranty for the lesser of ONE year / TWELVE THOUSAND miles, pro-rated at the lesser of SIX months / SIX THOUSAND miles, at which time the warranty covers 50% of the cost or repair or replacement performed by ACS, and decreases by an additional 8.34% per month / thousand miles. The unit is warranted to be merchantable and fit for its particular purpose in accord with the manufacturer's standards. Only parts repaired / replaced by ACS are covered by this warranty. Should a defect occur in the performance of the unit during the warranty period, customer must return the unit along with the proper claim form and purchase document(s). ACS in their sole judgment will determine the cause of the malfunction. If ACS determines that the failure of the unit is caused by a reason not covered by warranty, then the warranty claim will not be honored. If the malfunction is a result of the prior work of ACS, ACS will repair the unit. If the malfunction is in the unit itself, then ACS will provide a credit towards a replacement provided by ACS. Customer may then pay the difference for the pro-rated cost of repair or the replacement unit. Customer's failure / refusal to pay said difference voids the Warranty. Warranty does not cover: damage due to pre-existing electrical shorts; any P0600 codes; percussion to the unit; vehicular accident; loss of communications to the unit; fire; damage due to exposure to liquids; improper exposure to electricity; loss due to theft, misplacement or mishandling of the unit; loss during shipment; acts of God; unavailability of parts in the market at large; or other parts which may malfunction simultaneously or subsequently. Customer's failure to pay the balance due on any pro-rated repair or replacement under this Warranty voids the Warranty. Any tampering whatsoever with the unit or its programming voids the Warranty.
