## Meeting held 12<sup>th</sup> August 2021 – those present:

Apologies – Pat Moat – not available Monday, Tuesday or Wednesday evenings at present.

Minutes of last meeting – were approved and signed.

MAR: Welle Tidy – informed Cllr Lester that the Wheelie bin gate was locked.

**REFURBISHMENT**: Two tenders received - £403,000 and £395,000, twice as much as expected due to huge price increases in materials.

PW – reported that a discussion at Pc meeting two councillors suggested Bifold doors in the rear wall of hall. CA proposed choose a builder at an Extra-Ordinary meeting for council, architect to be invited to attend. A vote held was 8 – 0 with 2 abstentions. Build time between the two tenders was 12 – 14 weeks and monetary wise £7,000. BC has concerns regarding break down of each section of the build. Two grants received totalling £56,000, this includes payment for architects' fees. Apply for further grants, N.C.C. social infrastructure £200,000, Mick George- Grantscape £50,000/£35,000.

**GLASS WASHER**: Service carried out and invoice received. *Delivered to Parish Clerk 13/8 along with a letter from Lesley Bar Manager who was unable to attend.*
