

AXE THROWING WAIVER AND RELEASE OF LIABILITY

I, THE UNDERSIGNED PARTICIPANT, know and understand that axe throwing is an activity that involves significant risk of personal injury, death, or property damage. I also know and understand that there are additional conditions and risks, which independently, or in combination with these activities, may cause property damage, severe or even fatal injuries to me or others.

I agree and acknowledge that I have made a voluntary choice to participate in these activities at Clubs & Hatchets LLC with the risk that they present. I agree to assume any and all risk of injury or death which might be associated with, or result from, my participation in these activities. I agree to accept all responsibility for the risks, conditions, and hazards which may occur whether they now be known or unknown.

I further agree that I will accept and abide by all the rules and regulations of Clubs & Hatchets, as well as all obligations that may be imposed by any law.

In consideration for participating in the activity on the date as set out below, which consideration is hereby expressly accepted and acknowledged, I HEREBY RELEASE, ACQUIT, AND FOREVER DISCHARGE, WITHOUT QUALIFICATION OR LIMITATION AND HOLD HARMLESS Clubs & Hatchets LLC from any and all claims I may have now and/or in the future against Clubs & Hatchets, from any and all liability from any personal injury, death, and/or property damage, expense, and/or loss I may suffer as a result of participating in the activity due to any cause whatsoever including, but not limited to and without limitation, negligence, and/or breach of statutory or other duties, including my failure to take reasonable steps to safeguard or protect myself from the risks, dangers, and/or hazards for participating in the activity.

SEVERABILITY: If any provision of this document is determined to be invalid for any reason, such invalidity shall not affect the validity of any of the other provisions, which other provisions shall remain in full force and effect as if this document had been executed with the invalid provision eliminated

I, THE UNDERSIGNED PARTICIPANT, HEREBY CERTIFY THAT I AM AT LEAST 18 YEARS OLD, THAT I HAVE COMPLETELY READ AND UNDERSTAND THIS AGREEMENT AND ITS TERMS. I, THE UNDERSIGNED PARENT/ GUARDIAN HEREBY CERTIFY THAT I UNDERSTAND THE RISKS FOR ANY MINOR PARTICIPANTS, THAT THE MINOR PARTICIPANT IS AT LEAST 8 YEARS OLD AND THAT I HAVE COMPLETELY READ AND UNDERSTAND THIS AGREEMENT AND TERMS.

I HEREBY ACKNOWLEDGE (1) THAT THIS DOCUMENT IS VALID AND MAY BE ENFORCED IN THE SAME MANNER AS A HAND-SIGNED DOCUMENT THAT EXISTS IN PHYSICAL FORM. I ALSO EXPRESSLY ACKNOWLEDGE THE VALIDITY OF THIS DOCUMENT. I FURTHER AGREE THAT I HAVE KNOWINGLY AND EXPLICITLY WAIVED ANY RIGHT TO CLAIM THIS DOCUMENT IS INVALID OR IS UNENFORCEABLE BASED ON THE FACT THAT I HAVE NOT PUT PEN TO PAPER.

Rules for axe throwing:

1. Only ONE person throwing an axe at a time per lane.
2. Only ONE axe out of the box at any given time per lane.
3. NO double throwing axes. NO exceptions.
4. Remain entirely behind the throwing line until the thrown axe comes to a complete stop.
5. Throw the axe with one or two hands so that the blade faces the target before release.
6. One foot must remain on the floor during throws.
7. Waivers are required for all participants.
8. Obey the Axe Coaches' commands at all times.
9. No open-toed shoes. No exceptions.
10. Never handle or throw an axe until given permission by an Axe Coach.
11. Only overhand, one or two-hand throws are permitted.
12. Do not step over the throwing line before the axe hits or misses the target.
13. When the thrower is done, he/she must return the axe to the proper location, and the next thrower is to grab the axe from said location. DO NOT pass the axe to one another.
14. To ensure the safety of you and the other guests, if you seem too intoxicated at any time during play, staff has the right to cut you off from playing and/or drinking with no refund issued. No Exceptions.
