NOTE 1 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Nature of Operations

Kelyniam Global, Inc. (“the Company”), organized under the laws of the State of Nevada, specializes in the rapid production of custom prosthetic cranial implants utilizing computer-aided design and computer aided manufacturing of advanced medical grade polymers. The Company develops, manufactures, and distributes custom cranial implants for patients requiring the reconstruction of cranial and certain facial structures. The Company works directly with surgeons, health systems and payors to improve clinical and cost-of-care outcomes. The Company has additional products and categories in various stages of development and commercialization.

The Company’s business operations consist solely of regulatory approvals, manufacturing operations and distribution to customers and markets entirely in the United States.

Basis of Accounting

The financial statements of the Company have been prepared in conformity with accounting principles generally accepted in the United States of America (“GAAP”).

Reclassification

Certain prior year amounts have been reclassified to conform to the current period presentation.

Revenue Recognition

Revenue from the sale of implantable products is generally recognized at an amount that reflects the expected consideration at the point-in-time the hospital customer obtains control of the product, which is defined as when the product is delivered and accepted, or upon shipment to a third-party distribution customer assuming control of the products.

Significant judgments – contracts with multiple performance obligations

Generally, each customer order represents a separate contract. Customer orders may include promises to transfer multiple performance obligations. A performance obligation is a promise in a contract with a customer to transfer products or services that are distinct. Generally, each specific product or service ordered is considered distinct and therefore, considered a separate performance obligation.

The Company allocates the transaction price to each performance obligation on a relative standalone selling price (“SSP”) basis. The SSP is the price at which the Company would sell a promised product or service separately to a customer. Judgement is required to determine the SSP for each distinct performance obligation.

The Company determines SSP by considering its overall pricing objectives and market conditions on a customer basis. Significant pricing practices taken into consideration include the Company's discounting practices, price lists, historical sales and contract prices. As the Company's go-to-market strategies evolve, the Company may modify its pricing practices in the future, which could result in changes to SSP. In certain cases, the Company is able to establish SSP based on observable prices of products or services sold separately in comparable circumstances to similar customers. The Company uses a single amount to estimate SSP when it has observable prices.

The transaction price for each contract with a customer is generally fixed. Amounts that have been invoiced are recorded in accounts receivable and revenue, when control to customers has occurred.

The Company has determined that it qualifies for the practical expedient to expense incremental costs of obtaining a contract as incurred in the period that the goods or services are transferred to the customer as this treatment is consistent with the incremental costs incurred.

Use of Estimates

Management uses estimates and assumptions in preparing these financial statements in accordance with accounting principles generally accepted in the United States of America. Those estimates and assumptions affect the reported amounts of assets and liabilities, the disclosures of contingent assets and liabilities, and the reported revenues and expenses. Actual results could differ from those estimates.

Cash and Cash Equivalents and Credit Risk

The Company considers all investments with the original maturities of three months or less to be cash equivalents.

The Company maintains its cash and cash equivalents in bank deposit accounts that, at times, may exceed federally insured limits. The Company has not experienced any losses in such accounts and believes it is not exposed to any significant credit risk on cash and cash equivalents. The Company did not exceed the insured limit as of December 31, 2025 and 2024.

Accounts Receivable

Accounts receivable are recorded at fair value and are recorded as current assets. Uncollectible account balances are written-off when management determines the probability to collection is remote. The Company does not require collateral in providing credit. The allowance for doubtful accounts reflects the best estimate of probable losses determined principally on the basis of historical experience and specific allowances for known troubled accounts. All accounts or portions thereof that are deemed to be uncollectible or that require an excessive collection cost are written-off to the allowance for doubtful accounts. No allowance for doubtful accounts was deemed necessary at December 31, 2025 and 2024. The opening balance of accounts receivable as of January 1, 2025 was \$385,568 and the closing balance as of December 31, 2025 was \$414,875. The opening balance of accounts receivable as of January 1, 2024 was \$448,815 and the closing balance as of December 31, 2024 was \$385,568.

Inventory

Inventory, consisting primarily of supplies, is stated at the lower of cost (first-in, first-out basis) or market value (net realizable value).

Property and Equipment

Property, plant, and equipment are recorded at cost. Depreciation is provided using straight-line methods for financial reporting purposes. Estimated useful lives of the assets are as follows:

Manufacturing equipment	7 years
Computer equipment	3 years
Furniture and fixtures	5 – 7 years
Leasehold improvements	15 – 39 years

The cost and related accumulated depreciation of equipment and furniture sold, retired or otherwise disposed of are removed from the related asset accounts, and any resulting gain or loss is recorded in operations for the period in which the transaction occurred.

Expenditures for major renewals or improvements that extend the useful lives of equipment and furniture are capitalized. Expenditures for maintenance and repairs are expensed as incurred. Depreciation expense for the years ended December 31, 2025 and 2024 was \$12,383 and \$44,648, respectively.

Fair Value of Financial Instruments

The Company has a number of financial instruments and none are held for trading purposes. The Company estimates that the fair value of all financial instruments as of December 31, 2025 and 2024 does not differ materially from the aggregate carrying values of its financial instruments recorded in the accompanying balance sheets. The Company used available market information and appropriate valuation methodologies to determine the estimated fair value amounts. Considerable judgment is required in interpreting market data to develop the estimates of fair value and, accordingly, the estimates are not necessarily indicative of the amounts that the Company could realize in a current market exchange (See Note 10).

Advertising Costs

The Company expenses advertising costs as they are incurred. Advertising expenses for the years ended December 31, 2025 and 2024 was \$28,889 and \$28,309, respectively.

Shipping and Handling Costs

All shipping and handling costs billed to customers are recognized in sales. Shipping and handling costs are charged to expense as incurred and included in cost of sales on the accompanying statement of income. Shipping and handling costs incurred for the years ended December 31, 2025 and 2024 was \$35,186 and \$36,794, respectively.

Income Taxes

Income taxes are provided for the tax effects of transactions reported in the financial statements and consist of taxes currently due plus deferred taxes related to differences between financial statement and taxable income arising primarily from future benefits for net operating loss carryovers for tax purposes.

The deferred tax assets and liabilities represent the future tax return consequences of those differences, which will either be taxable or deductible when the assets and liabilities are recovered or settled.

There are no uncertain positions that would require recognition in the financial statements. If the Company were to incur an income tax liability in the future, interest on any income tax liability would be reported as interest expense and penalties and income tax would be reported as income tax expense. Management's conclusions regarding uncertain tax positions may be subject to review and adjustment at a later date based upon ongoing analysis of or changes in tax laws, regulations and interpretations therefore as well as other factors.

Lease Accounting

In February 2016, the Financial Accounting Standards Board (FASB) issued guidance (*Accounting Standards Codification [ASU] 842, Leases*) to increase transparency and comparability among organizations by requiring the recognition of right-of-use (ROU) asset and lease liabilities on the balance sheet. Most prominent amount the changes in the standard is the recognition of ROU assets and lease liabilities by lessees for those leases classified as operating leases. Under the standard, disclosures are request to meet the objective of enabling users of financial statements to assess the amount, timing, and uncertainty of cash flows arising from leases.

The Company adopted the standard effective January 1, 2022 and recognized and measured leases existing at, or entered into after, January 1, 2021 (the beginning of the earliest comparative period presented) using a modified retrospective approach, with certain practical expedients available.

Available practical expedients were elected to account for existing capital leases and operating leases as finance leases and operating leases, respectively, under the new guidance, without reassessing (a) whether the contracts contain leases under the new standard, (b) whether classification of capital leases or operating leases would be different in accordance with the new guidance, or (c) whether the unamortized initial direct costs before transition adjustments would have met the definition of initial direct costs in the new guidance at lease commencement.

In addition, the hindsight practical expedient was elected to determine the lease term for existing leases. The election of the hindsight practical expedient did not result in a change of lease terms for existing leases or a change in the useful lives of corresponding right-of-use assets. In the application of the hindsight practical expedient, the Company concluded that renewal options would not be reasonably certain in determining the expected lease terms.

The Company leases building space and determines if an arrangement is a lease at inception. Operating leases are included in operating lease right-of-use assets and operating lease liabilities shown on the Balance Sheet. Annual rentals pertaining to the real estate lease, which convey merely the right to use property, are charged to current operations. The Company's monthly installments range from \$2,667 to \$2,830, maturing December 2027.

ROU assets represent the right to use an underlying asset for the lease term and lease liabilities represent the obligation to make lease payments arising from the lease. The Company calculates operating lease liabilities with a risk-free discount rate, using a comparable period with the lease term. All lease and non-lease components are combined for all leases. Lease payments for leases with a term of 12 months or less are expensed on a straight-line basis over the term of the lease with no lease asset or liability recognized

The lease agreements do not contain any material residual value guarantees or material restrictive covenants.

There were no short-term leases in 2025 or 2024. Should there be in future years the short-term exemption will be applied.

Adoption of New Accounting Standards

In June 2016, the FASB issued ASU 2016-13, Financial Instruments – Credit Losses (Topic 326): Measurement of Credit Losses on Financial Instruments, which replaces the current methodology required to measure and disclose incurred loss impairments under GAAP with one that reflects expected credit losses and that requires consideration of a broader range of reasonable and supportable information to inform credit loss estimates. ASU 2016-13, and related ASUs that amend or clarify certain provisions therein, are effective for fiscal years beginning after December 15, 2022. Early adoption was permitted. Management adopted the standard in 2023 which had an immaterial effect on the financial statements.

Subsequent Events

In preparing these financial statements, management has evaluated subsequent events through February 13, 2026, which represents the date the financial statements were available to be issued.

NOTE 2 – RELATED PARTY TRANSACTIONS

Former Officer/Employee Loan Payable

Loan payable represent amounts due to a former officer/employee. The outstanding balance of the loan as of December 31, 2025 and 2024 was \$17,270 and \$26,122, respectively. The amount is not subject to a specific repayment schedule. The note pays interest at 4.75%.

NOTE 3 – INVENTORY

Inventory consists of supplies on hand in the amount of \$44,823 and \$34,788 as of December 31, 2025 and 2024, respectively.

NOTE 4 – LINE OF CREDIT

The Company has a \$230,000 revolving line of credit with Westfield Bank, secured by the assets of the Company. The balance on the line at December 31, 2025 was \$222,117 at the rate of interest of 8.0%. The balance on the line at December 31, 2024 was \$55,959 at the rate of interest of 8.50%.

During the third quarter of 2025, the Company issued 825,000 shares of common stock at various issuance prices primarily to current Board members and employees in the amount of \$77,550.

During the fourth quarter of 2025, the Company cancelled previously acquired common stock shares held by its transfer agent and not expected to be reissued. No resources were utilized in the quarter for this cancellation.

As of December 31, 2024, the authorized capital stock of the Company was 60,000,000 shares of common stock, \$0.001 par value per share; 49,718,430 shares outstanding at December 31, 2024.

The Company awarded an employee 150,000 shares of stock which will vest over 3 years upon the anniversary of the employee's service at the Company during the first quarter. The first 50,000 shares award was provided in February 2024 at \$0.06 per share for a total amount of \$3,000. A second tranche was awarded to the employee on the anniversary of their workdate in July 2024 for a total amount of \$3,500. The Company has chosen to use the cash or intrinsic method of accounting to account for the award of shares in 2024.

During the second quarter of 2024, the Board awarded an outgoing Board member 300,000 shares of common stock in recognition of lengthy service to the Company in the amount of \$18,000.

During the third quarter of 2024, the Company issued 375,000 shares of common stock to current Board members for “2024-2025 Board Service in the amount of \$45,000.

The Company undertook a Private offering of Public Equity (“PIPE”) at a fixed price which closed at the end of November. 4,464,285 of common shares were issued in the fourth quarter of 2024. No warrants or other dilutive instruments were issued in conjunction with the offering.

In addition, during the fourth quarter of 2024, the Board authorized and the Company issued 14,556,000 shares of common stock to current officers in respect to compensation obligations in the amount of \$873,360.

NOTE 9 – RETIREMENT PLAN

The Company maintains a 401(k) plan for full-time employees defined as an employee whose schedule services exceed 1,000 hours during a calendar year. Newly hired employees are eligible to participate in the plan after six months of service. The Company's accrued matching contribution to its' 401(k) plan during the year ended December 31, 2025 was \$13,410 and an additional \$8,358 was paid for 2024. The Company's accrued matching contribution to its' 401(k) plan during the year ended December 31, 2024 was \$5,710.

NOTE 10 – FAIR VALUE MEASUREMENTS

FASB 820, Fair Value Measurements and Disclosures (FASB ASC 820) established a framework for identifying and measuring fair value. FASB ASC 820 provides a fair value hierarchy, giving the highest priority to quoted prices in active markets, and is expected to be applied to fair value measurements of derivative contracts that are subject to mark to market accounting and other assets and liabilities reported at fair value.

FASB ASC 820 defines fair value, establishes a framework for measuring fair value and expands disclosures about fair value measurements. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

FASB ASC 820 emphasizes that fair value is a market-based measurement, not an entity specific measurement, and establishes a fair value hierarchy that distinguishes between assumptions based on market data obtained from independent sources and those based on the entity's own assumptions. The hierarchy prioritizes the inputs to fair value measurements into three levels:

Level 1- measurements utilize unadjusted quoted prices in active markets for identical assets and liabilities that the entity had the ability to access. These consist primarily of listed equity securities, exchange traded fixed income, derivatives and certain U.S. government treasury securities.

Level 2- measurements include quoted prices for similar assets and liabilities in active markets, quoted prices identical or similar assets or liabilities in markets that are not active, and other observable inputs such as interest rates and yield curves that are observable at commonly quoted intervals. These consist primarily of non-exchange traded derivatives such as swaps, forward contracts of options and most fixed income securities.

Level 3- measurements use unobservable inputs for assets and liabilities, are based on the best information available and might include the entity's own data. In some valuations, the inputs used may fall into different levels of hierarchy. In these cases, the financial instrument's level within the fair value hierarchy is based on the lowest level of input that is significant to the fair value measurement. These consist mainly of assets and liabilities valued through an internal modeling process.

The following section describes the valuation methodologies used by the Company to measure different financial instruments at fair value, including an indication of the level in the fair value hierarchy in which each instrument is generally classified. Where appropriate, the description includes the details of the valuation models, the key inputs to those models, and significant assumptions.
