Assembly Delegate Baptist Churches of NSW & ACT

## **Role Description**

Represent and vote on behalf of Kurri Kurri Baptist Church at Assemblies and Meetings held by Baptist Churches of NSW & ACT, and report to Church meetings as required

## **Responsibilities**

- Attend Baptist Churches of NSW & ACT meetings as able
- To ascertain that the Church Secretary has confirmed Registration for Baptist Churches of NSW & ACT meetings, when this is required
- Take advice, and receive instruction, from the Church on any contentious issues
- To follow the directions of Kurri Kurri Baptist Church when voting at Baptist Churches of NSW & ACT meetings
- Provide feedback to the Church regarding decisions, and information provided from Baptist Churches of NSW & ACT
- A Non-voting Delegate can represent Kurri Kurri Baptist Church at Assemblies and Meetings

## **Prerequisites and/or skills required**

- Church Member, over the age of 18, who has personally experienced the doctrine of the baptism of believers only by immersion, as per the Constitution (5A)
- Compliance with the Procedure for Staff and Volunteers (Category 2b - Volunteers not in leadership roles or engaged in child-related work or work with vulnerable adults)

## **Supported by**

- Church Leadership, and Church
- Baptist Churches of NSW & ACT

## **Term**

- Nominated by a regular Church attendee (Member or Non-Member), and affirmed at the Annual Church Meeting
- One year term, with eligibility for re-nomination for subsequent terms

## **Reporting to**

- Church Leadership, and Church

## **Reporting method and frequency**

- Verbal or written reports for the Church as required
