PLEASE READ CAREFULLY

In consideration of my child (printed full name of the participant) _____ participation in the Wild Roots Nature and Forest School program, I the undersigned, the Parent/Guardian acknowledge and agree to the following:

1. ACKNOWLEDGMENT AND ASSUMPTION OF RISKS

The Parent/Guardian acknowledges and agrees that he or she is aware that there are many known and unknown dangers and risks associated with participation in the outdoor nature program including, but not limited to, the risk of minor injuries such as cuts, bruises, and scrapes, insect bites, insect stings, as well as the risk of serious injury or death. The Parent/Guardian acknowledges and agrees that he or she understands the aforesaid dangers and risks associated with the outdoor nature program and notwithstanding such dangers and risks agrees to provide his or her permission for the Student to participate in the outdoor nature program.

2. RELEASE AND WAIVER OF CLAIMS

The Parent/Guardian releases, waives, and fully discharges Wild Roots Nature and Forest School from any and all claims, demands, obligations and liabilities of any kind or nature whatsoever arising from or connected, directly or indirectly, with the Student's participation in the outdoor nature program due to any cause whatsoever, including negligence, breach of contract, and breach of any statutory duty of other duty, and the Parent/Guardian accepts that this release covers and includes, but is not limited to, all unknown and unforeseen claims, injuries, damages and losses, and any consequences thereof.

3. INDEMNITY

The Parent/Guardian will indemnify and hold harmless Wild Roots Nature and Forest School from any damage, loss, liability, legal costs and other expenses that Wild Roots

Nature and Forest School may suffer or incur by reason of any claims against Wild Roots Nature and Forest School arising from or connected, directly or indirectly, with the Student's participation in the outdoor nature program, including any claim based on negligence, breach of contract, and breach of statutory duty or other duty.

I have read and understand the information contained in the Parent Handbook provided by Wild Roots Nature and Forest School.

I will not hold Wild Roots Nature and Forest School responsible for any lost or stolen items.

The safety of Wild Roots Nature and Forest School Students is our top priority. During Forest School, the educator's role is to make sure the group is physically safe and comfortable. We also assess the overall safety of the site and the risk management required for specific activities.
