# 2023 Immunization Champion Award



The Immunization Champion Award, hosted by the Association of Immunization Managers (AIM) and funded by the Centers for Disease Control (CDC), recognizes individuals doing an exemplary job or going above and beyond to promote or foster immunizations in their communities for children and adults. Each awardee was nominated and selected from a pool of health professionals, community advocates, and other immunization leaders for significantly contributing to public health in their community.

# 2023 NC Immunization Champion

#### North Carolina - Katherine A. Poehling, MD, MPH



Katherine A. Poehling, MD, MPH, is a professor of pediatrics and epidemiology and prevention at Wake Forest School of Medicine and a board-certified pediatrician with Atrium Health Wake Forest Baptist Medical Center. She served as a voting member of the Advisory Committee on Immunization Practices (ACIP) during the COVID-19 pandemic. In addition to her ACIP work, Dr. Poehling is an active member of the North Carolina Pediatric Society and part of a core group of members who meets regularly with the North Carolina Immunization Program to improve vaccine efforts within the Vaccines for Children and COVID-19 Provider Vaccination Programs. Dr. Poehling is an expert on the community impact of vaccines, specifically pneumococcal and influenza.

"Dr. Poehling's work helped to shape the COVID-19 vaccine recommendations for the United States in addition to other vaccine recommendations that have occurred during her tenure as an ACIP member."
