Covered Components

ENGINE: Cylinder heads, Engine block, All internal engine parts, lubricated and non-lubricated, Timing chain, timing belt and timing gears, Intake manifold, EGR and Sensor. Not covered: Engine oil leaks and variable valve timing (VVT) components. Diesel engines are not covered unless option selected.

TRANSMISSION: (Automatic or Manual) Transmission case and all internal parts, lubricated and non lubricated, Torque converter and housing, Manual transmission, Manual clutch components are wearable items and are not covered. Four Wheel Drive transfer case and all internal parts.

DRIVE AXLE: Front and rear drive axles and all internal parts; Universal joints and constant velocity joints; drive shaft, yokes and drive shaft carrier. Hub/wheel bearings not covered. Damaged or missing cv boots will void coverage of affected components.

FUEL SYSTEM: Pump, lift pump, transfer pump. Fuel injector pump and fuel injectors are not covered.

COOLING SYSTEM: Radiator, fan and fan clutch, Electric radiator fan motor, Water pump.

AIR CONDITIONING: All factory installed front air conditioning systems, compressor, clutch, coil, evaporator, condenser, accumulator/dryer, and expansion valve.

Not Covered: Evacuate, Recharge, Flush, Refrigerant and R12 (Freon) systems and rear air conditioners.

STEERING: Steering gear, Rack and pinion assembly, Power steering pump, cooler and cooler lines.

SUSPENSION FRONT: Springs, Control Arms and Ball Joints are covered on cars only. Control Arms / Ball joints are not covered on trucks and SUV's.

SUSPENSION REAR: Springs.

BRAKES: Master Cylinder, (ABS) Anti Lock Brakes -Hydraulic Components, Control Module. Not covered: Speed sensors, pads, shoes, hoses, lines, wiring, drums, rotors, calipers and pistons.

ELECTRICAL: Power Window Motors, Power Seat Motors, and Power Door Lock Actuators. Alternator, front and rear wiper motors, starter motor.

SEALS AND GASKETS: Cylinder Head Gaskets and Manifold Gaskets are covered for coolant leaks only. All other Seals and Gaskets are only covered in conjunction with covered repair. Engine oil leaks are not covered.

DIESELS and TURBOS are EXTRA CHARGE OPTIONS on this contract.

LABOR: Labor time for repair shall be based on industry standards. Labor rate will not exceed \$80.00 per hour.

TOWING: If your vehicle needs towed due to the failure of a covered component we will reimburse you up to a maximum of \$50.

TERMS AND CONDITIONS: This limited warranty is between the vehicle owner stated above and Auto Pro Warranty Company, LLC. Auto Pro Warranty Company, LLC will make payment to you or the repair company for the repair or replacement of components covered by this limited warranty that are found to be defective or worn beyond serviceable limits through normal wear and tear. Coverage begins when this application and payment are received and approved by Auto Pro Warranty Company, LLC and will be in effect for the time or mileage period whichever occurs first as specified on the contract. The covered component failure must occur during the limited warranty coverage period under normal usage. Any claim within 250 miles of current odometer reading shown above will be considered a pre-existing condition and will not be covered. Any listed components that fail prior to the approval by Auto Pro Warranty Company, LLC of this limited warranty application are not covered. Only components listed above are covered. No other components are covered regardless of cause of failure. Replacement components shall be of the same type, quality and mileage as those removed which may include used, reconditioned or aftermarket components. Other items not covered include but not limited to; oil consumption, damage resulting from improperly maintaining or failing to maintain the vehicle; damage that results from any previous or improper repair; damage from physical damage, collision, theft, fire, accident, conditions of the environment, including rust and corrosion; damage from overheating, damage that results from altering, misusing or tampering with the vehicle; damage that results from making improper adjustments or using improper fuels or fluids; damage to a covered component caused by failure of a non-covered component; fluid leaks and damage caused by fluid leaks. Continued operation after the initial failure that results in further damage is considered abuse and is not covered. Preventative maintenance of covered vehicle is the responsibility of the vehicle owner which will include but not limited to parts and labor, fluids, oil, filters, fan belts, radiator hoses and radiator thermostat or any part of the vehicle that is subject to normal wear and tear. Mismatched tires will void four wheel drive or all wheel drive components. An inoperative, malfunctioning or altered odometer will void this limited warranty. Auto Pro Warranty Company, LLC will not be responsible for lost time or any inconvenience caused by the loss of usage of your vehicle; the quality of the repair by the repair facility or for any other incidental or consequential damages you may have. Vehicle owner is responsible for the following charges on a covered repair; Sales tax, fluids, tear down and diagnosis. The deductible amount per claim on this limited warranty is \$100 per occurrence. Vehicle owner is responsible for maintaining the vehicle properly and in accordance with manufacturers specifications and must retain receipts of any work or maintenance performed. At our option we may request copies of these maintenance receipts. Repairs done outside of the continental United States will not be covered. **CLAIM PROCEDURE:** Covered vehicle must be at a qualified repair center of your choice to open a claim. The repair center must call Auto Pro Warranty Company, LLC at 888-442-7555 to initiate a claim. Once a claim has been initiated the repair center must provide Auto Pro Warranty Company, LLC with an estimate of repairs BEFORE the
