

TELEMEDICINE MEDICAL MARIJUANA RECOMMENDATION WHAT YOU NEED TO KNOW

Please note: This application process is 100% online. Please go to the application webpage at: OMMA.OK.GOV (you can type this into your web browser), All the information regarding the application process is on the state OMMA website.

If after reading this document you still have questions about the telemedicine process, please call 918-640-6937 for clarification.

WHAT IS TELEMEDICINE? Telemedicine is an online way for a physician to see and evaluate a patient remotely (Does not involve the patient and doctor to be at the same location). This can be done from the comfort and convenience of your own home!

WHAT KIND OF COMPUTER SETUP DO I HAVE TO HAVE? You will need video (your device must have a camera) and audio (microphone) capability. These are commonly already on most smart phones, home computers, and lap tops. You will also need a good internet connection, either by WiFi or by your cellular phone internet access (cellular phone data plan). If you will be using your home WiFi system it would enhance the quality of your appointment if your home WiFi did not have other devices using your WiFi network at the time of your appointment (such as Play Stations, X Box's, other home computers, phones, etc.). If you browse the internet on a private browser setting (for instance the iPhone browser Safari has private internet access capability and the telemedicine process will not work while the browser is set in this mode), please turn off the private browsing setting in preparation for your appointment. You may resume the private settings after your appointment.

If there is a problem connecting online, the doctor will call you at the number we have on file for you.

WHAT ELSE DO I NEED FOR THE TELEMEDICINE APPOINTMENT? **No medical records are necessary!** Good lighting and a private quiet room will help ensure the doctor can see and hear your properly (excessive environmental noise will make it difficult for the doctor to hear you). If computers are not your thing, it

may be helpful to have a computer experienced friend or family member available to assist you if necessary.

Please Note: The Oklahoma Medical Marijuana Authority (OMMA) will not accept a P.O. Box Address on your recommendation form. You MUST enter your physical address during the appointment booking process.

HOW WILL I GET MY PHYSICIAN RECOMMENDATION FORM AFTER MY APPOINTMENT? If the doctor determines that Medical Marijuana would be appropriate for you, the doctor will email your OMMA Physician Recommendation form to you at the email address we have on file by 6:00 PM the day of your appointment. PLEASE notify us as soon as possible if you did not receive your documents by then.

WHAT IF THE DOCTOR DOESN'T RECOMMEND MEDICAL MARIJUANA FOR ME? Should this rare situation ever occur, you will be refunded your fee, less a service fee of \$25 to cover our expense to process your transactions. If you have concern that you may not qualify, call 918-640-6937 and we will help to clarify your particular circumstances.

How do I schedule my appointment?

You will need to schedule your appointment no later than 1 hour in advance. This allows our team time to prepare the necessary documents for your appointment.

You will be sent to our scheduling page.

****Please complete registration on the appointment scheduling page. Click on the link to begin the registration process at the top of the screen you see after clicking the "Book Here" button. Follow the directions to complete your appointment. The information you enter during this process will be used to complete your physician recommendation form, so accuracy of your information IS CRITICAL!!!**

What do I do on the day of my appointment? On your device's web browser application (Safari, Google, etc.) Please go to: <https://doxy.me/drsnedden> Follow this link at least 5 minutes before your scheduled appointment to check in to the doctor's waiting room. If you are asked, please allow this website permission to access your device's microphone and camera.

The doctor will soon greet you and discuss your medical conditions with you in order to determine your eligibility for an Oklahoma Medical Marijuana License.

What do I do if I cannot keep the appointment I scheduled? You may reschedule without additional fee. You can do this by logging back into your appointment (this will be possible only if you registered while booking your appointment). Please see ** above under the section: "**How do I schedule my appointment?**". This is where you would have originally registered. You may also call our office at 918-640-6937 and we will work with you to remedy your situation.

What if I have to cancel my appointment? You may cancel up to 12 hours in advance of your appointment. You will be charged a \$25 service fee to cover the transaction fees we incurred to process your transactions. If you cancel within 1 hour of your appointment there will not be a refund.
