Safe Haven was blessed enough to be able to open our Men's sober living home housing 12 men, and expanded our staff to 23 employees. Transportation continued in 3 counties and expanded to assist our men's home and intensive outpatient participants! Our coaches all received training and attended conferences to keep their skills up to date while helping other people in need, and our organization as a whole received great support from the community, donors, and grant makers throughout the counties we serve. We thank the community for their support and look forward to even more servant work in 2026!

Message from CFO



2025 was a year of growth and challenges for our organization, especially at the grant level. Safe Haven REC is a 501c non-profit organization and is run exclusively on grants and donations from the community, so that we may always offer free services. 2025 brought the expansion of our RRH grant to cover 13 counties and partner with another organization to help serve those counties. 2025 also brought the completion of two grants: DMHA Opioid Match Settlement Grant and our IU Community Investment Impact Grant. 2025 came with many unknowns, wavering grant support or limited grant support due to various political climate changes; all of which Safe Haven was able to maneuver. I am particularly proud of the ability of Safe Haven REC to economically impact Orange County and Vanderburgh County by hiring and maintaining 23 employees who, most if not all, would not have careers if not for Safe Haven. At Safe Haven REC, we foster and cater to who they are now; not who they were.

I am forever grateful and humbled by the immense support we receive from all levels throughout our local towns, counties, and state as well as for our partners in funding through various state, private, and foundational stakeholders that make our work possible. We are excited to usher in 2026 and bring even more of the same great resources to the counties we serve.

About Safe Haven Recovery Engagement Center

Safe Haven Recovery Engagement Center (REC) is a 501c non-profit organization in Orange County, Indiana. Founded in 2018 after the loss of Brittany's brother, Dakota, to an overdose, Safe Haven started as an information center run by volunteers. Quickly recognizing the many needs of the community, Safe Haven REC expanded into a Recovery Community Organization (RCO). We began providing recovery coaching and other services in 2020 and became a Certified RCO through DMHA in 2023. We now serve 13 counties and provide a multitude of resources and support to include recovery coaching, transportation, Narcan distribution, harm reduction supplies, food support, hygiene support, community education, men's sober living, food pantry, and celebratory recovery events. All of our services are offered free to the community. We are completely grant and donation funded since we do not charge for any of our services.

Programming

Safe Haven provides a multitude of resources to the communities we serve. All of the resources that we offer are free to the community.

Recovery Coaching

Our recovery coach program is a program offering one on one mentorship to people seeking recovery from substance use and/or mental health concerns. All of our coaches are certified in the state of Indiana and are people with lived experience. Participants in this program receive weekly individual meetings to remove barriers and develop a recovery plan that works for them. Participants can stay in this program for as long as they feel it benefits them.

Transportation

Transportation is a free service offered in Lawrence, Orange, Crawford, and Dubois counties. Utilizing paid drivers and our own fleet of vehicles, Safe Haven REC offers free rides for anybody currently or previously involved in the criminal justice system. This service can be used for rides to and from work, appointments, probation, peer support meetings, or running errands.

Food Pantry

Safe Haven opened a food pantry in 2025 due to the continued and increasing need we saw in the population that we serve. Our food pantry is accessible weekly for individuals in need and we aim to offer a variety of food options including pantry staples, meat, dairy, and fresh produce. Our food pantry is open three days a week.

Salvation Army

Safe Haven Paoli location is home to Orange County's Salvation Army representative. This service is open to anybody in need residing in Orange County.

Harm Reduction

Harm reduction saves lives. With harm reduction we focus on keeping people alive and safe until they find the right recovery path that works for them. Safe Haven offers Naloxone free of charge. Safe Haven monitors and stocks 9 Naloxboxes throughout our service area and serves as a pass through to distribute Naloxone to other organizations. We also offer fentanyl test strips, xylazine test strips, and wound care supplies as needed.

Events and Awareness

Safe Haven REC regularly aims to celebrate recovery, spread awareness of resources and treatment options available, and reduce stigma surrounding substance use and mental illness. We do this by offering a variety of pro-social activities and events in our service area and being active on social media.

Homeless Outreach

Our most vulnerable of our vulnerable populations we serve are the unhoused. Safe Haven offers support through all our programs to the unhoused population as well as supplies they may need such as sleeping bags, tents, warm clothing, and hygiene items. We also offer mailboxes at our Paoli location.

Street Outreach

Our street outreach teams serve Orange, Crawford, and Perry counties. These coaches provide a cooked meal and access to resources for people that need it, often setting up in community-oriented areas such as parks, food pantries, or other local organizations that allow us to set up. This program meets people where they are at, reducing the barrier of needing to come to our physical location to access services.

Family/youth coaching

Safe Haven REC has a family recovery coach on staff that works specifically with youth and family members impacted by substance use. Substance use is a family disease and this mentoring opportunity provides support to those impacted as well.

School Programming

Our family coach offers curriculum and programming designed specifically for youth and is designed to be administered and reported through the local school systems. This is a free service to the school systems to help empower youth that might be struggling with substance use to find recovery. Our program involves a variety of aspects including one on one mentorship, community service, family involvement and evaluation, and educational curriculum focused on substance use. This program is suitable for illicit substance use as well as alcohol and nicotine abuse.

Groups

Safe Haven offers group peer support meetings at our Paoli location; lists all known peer support meetings on our social media page; and has a coach that runs various types of groups in our service area including AA, NA, Smart Recovery, and Celebrate Recovery. Other group

offerings are available upon request as well such as lifeskills classes and anger management. Our groups coach hosts and manages multiple groups weekly across our service area.

Sober Living

Dakota's House is a 12 bed men's sober living facility in Paoli, Indiana. Dakota's house is a long-term sober living treatment environment offering full programming to the men that live there. Men are required to hold employment, complete Intensive Outpatient Services, attend peer support meetings, and provide community service work as part of the program. Dakota's House is managed by a live-in House Manager.

Employee Supports

Safe Haven cannot do all the amazing work we do without our employees. Our employees encounter unique needs and challenges related to their jobs. Safe Haven supports their employees by offering a gas stipend once weekly since they use personal vehicles to travel for their job as well as a mechanical assistance fund that can be accessed for vehicle repairs.

Sponsorship Program

Our participant sponsorship program is a unique way for people to support our work. Participants are individuals working with a recovery coach at Safe Haven. Often times, they have a small need or want that would help them in their recovery journey. We publish these needs and wants on our website for community members to browse and if so led, can purchase as a sponsorship for that participant. Needs vary from a simple word search book to combat boredom to a warm coat for the winter.

Safe Space/Community Center

Our physical location in Paoli has transformed into a true community center over the last year. Our open floor plan allows people to come in and just be. They can grab a cup of coffee, a snack, and watch some TV or charge their cell phones. Our physical location provides respite from heat and cold for many of our unhoused populations and serves as a congregation point or a meeting spot for any person or organization that wishes to utilize it.

Jail Hygiene Program

The jail hygiene program is specific to Orange County Jail. Monthly, Safe Haven provides all inmates with a basic hygiene bag that includes soap, shampoo, toothbrush, toothpaste, toilet paper, and deodorant. We often include small snacks like a bag of chips or a candy bar. For women we include feminine hygiene products.

Safe Haven continues to be a strong and vital community partner in all counties we serve. Safe Haven REC has had strong involvement in 2025 and the following activities reflect our dedication to service work, community awareness, and community partnerships.

Jail Hygiene Program

The jail hygiene program provided 606 hygiene bags to Orange County Jail inmates in 2025.

Our transportation program covers Crawford, Dubois, Orange, and Lawrence counties. Our transport team also offers free transport to and from IOP. The following data is in relation to our transport program.

Naloxone Distribution

Safe Haven distributed 1,523 doses of Naloxone in 2025.

Recovery Coaching Program

Safe Haven did 681 intakes on new individuals in 2025. We served a total of 2,056 for the year. This larger number is NOT unique individuals. Some individuals would have been served for more than one month, thus counted twice.

Food Pantry

The food pantry started in March 2025. November was a busy month with the suspension in SNAP benefits. For the year 2025 we served 3,827 individuals.

Salvation Army

The Salvation Army representative served 91 individuals in 2025.

Street Outreach

Street outreach is available in Orange, Perry, and Crawford Counties. In 2025, street outreach served 528 meals.

Challenges

Every year comes with challenges. 2025 proved to be one of our most challenging years.

Financially, there was a lot of turmoil in the grant world especially around federal funding. Federal funds move to the state which moves to organizations so the impact trickles down. In 2025, Safe Haven did receive a 21% reduction in funding due to budget cuts as well as 2 grants that ended their cycle in 2025. While we are very blessed to have been able to find sustainability plans for the majority of our staff and programming, Safe Haven did have to close down our Harm Reduction Mobile Unit in June 2025.

Our building proved challenging with septic issues in 2025 and we lost our very first vehicle purchased: Safe Haven -1 to a deer in 2025.

Despite these challenges, we were able to pivot, navigate, and continue pursuing our mission of recovery for everybody!

Needs

As we look on into 2026 our needs are generalized. We will be looking for support to fund some basic operation costs such as business phones, internet, email subscriptions. We will also be needing new laptops in 2026. Volunteers are always appreciated as well for events.

Looking Ahead

So what does 2026 have in store for Safe Haven and the service area we cover?

- Implementation and launch of a phone application for Safe Haven resources, events, and notifications
- Implementation of an organization wide policy and procedure management system
- Expansion of naloxbox access in our service area
- Introduction of a business technical assistance program for 2nd chance employers
- Renovation of our lobby space to become more of a community center
- Renovation of our kitchen for floor repairs
- Events:
 - Resource day for unhoused individuals: May 2026
 - 2nd chances Masquerade Ball April 30th 2026 at French Lick Hotel
 - Voices of Recovery Orange County: September 2026
 - Voices of Recovery Warrick County: September 2026

- Celebrate Orange County Recovery: June 2026
