"Further, each member owning a lot described as Lot 1, 2, 3, 4, 5, 6, 7, 8, 9, 10 or 11 on the plat described in Exhibit "A" shall have all rights as riparian owners under the laws of the State of North Carolina across such portions of Tract C as lies within the line marked "Riparian Boundary" immediately adjacent to such lot, including but not use boat docks within such portions of the common areas. Such riparian rights shall be subject to all applicable governmental regulatory requirements and restrictions and the provisions of Article IX hereof. The Declarant reserves the right to grant such rights to owners of other lots that may later be incorporated into the Properties as to those common areas upon which such lots join.
