## PARENT HANDBOOK - TRADITIONAL SITES

Corporate Status: Boys & Girls Club of Weslaco Inc. is a non-profit 501(c) 3 Corporation under the laws of the State of Texas, April 2013, chartered by the Boys & Girls Club of America.

Authority: The Club's authority is Mid-Valley. It is the only youth service organization that primarily emphasizes reaching economically disadvantaged youth.

Club Management: A volunteer Board of Directors manages corporate affairs. The Executive Director is accountable to the board and manages the Boys & Girls Club operations of Weslaco Inc.

**Funding:** The Boys & Girls Club of Weslaco is funded by Corporate and individual donations, an annual fundraising campaign, and an annual Bar B Oue Cook-Off. Other fundraising is club staff-led events.

Mission Statement: To inspire and enable all young people, especially those from disadvantaged circumstances, to realize their full potential as productive, responsible, and caring citizens.

**Vision Statement:** Safe havens for youth, providing generation-changing outcomes.

Core Beliefs: A Boys & Girls Club provides a safe place to learn and grow ongoing relationships with caring adult professionals, life-enhancing programs, character development experiences, and hope and opportunity.

### **Core Program Areas:**

<u>Character Development</u> programs empower members to support and influence their Club and community, sustain meaningful relationships with others, and develop a positive self-image. Participate in the democratic process and respect their own and other cultural identities.

<u>Health and Life Skills</u> develop members' capacity to engage in positive behaviors that nurture their well-being, self-esteem, personal goal setting, and ability to live successfully as self-sufficient adults.

### To the Parents/s or Guardian/s:

Welcome to the Boys & Girls Club of Weslaco Inc.'s traditional after-school program! We are excited to welcome your child(ren) to our vibrant club, where they can gain experience, grow, and make lasting friendships. This handbook serves as a comprehensive guide to familiarize you with our various policies, procedures, and guidelines, which help ensure a safe and enriching environment for all participants.

These pages have important information about our activities, staff, and values. After reviewing the handbook, if you have any questions or need further clarification, we encourage you to contact our program director at the administrative office at (956) 973-1610. We are here to aid you and ensure your enjoyable and rewarding experience with us!

The staff of all Boys & Girls Club sites have had a criminal and sex offender background check to assure the safety of your child(ren), All volunteers must pass the background check.

Our intention and goal is to keep you well-informed about all programs and activities. Parent meetings are held periodically. Please attend these meetings if possible. Special notices are posted on the bulletin board at each site. Please check the board weekly for notices of special events, activities, etc.

We have many volunteer opportunities and would welcome and appreciate your participation in planning and conducting special events. Contact the program site director at the administrative office for more information. As with our staff, we require criminal background checks for volunteers working with children at any of our sites.

Hours and Days of Operation: Traditional sites are open Monday through Friday from school dismissal to 6:30 p.m. beginning the first day of the school year and continuing through the last day. When your child(ren) attends a new site, be sure they are checked in with the front desk, as they will need emergency information for your child(ren).

The Club follows the Idea School Calendar, but in the Summer, we are open in June and July. Please call the site for exact dates and hours: (956) 973-1610

**Membership and Registration:** The monthly membership fee is \$45.00 and must be paid with registration. All membership forms and Parent Handbook acknowledgment must be completed, signed, and returned to the site before your child(ren) may participate in the Boys & Girls Club of Weslaco Inc. program. To provide the best possible care, please inform the Site Director of any changes in emergency contact information and phone numbers.

**Surveys:** As part of the National Boys & Girls Club Program, we conduct an annual survey to ensure our Club's programs meet the needs and interests of your child(ren). All information provided in this survey is kept private and confidential. Your child(ren)'s participation is voluntary. Please notify the Site Director if you prefer your child(ren) not to participate.

Arrival and Departure: The Boys & Girls Club of Weslaco Inc. is a Traditional Boys & Girls Club site. It is not licensed as a daycare provider. Your child(ren) will always be supervised at the club site; however, we do not allow your child to walk out without the parent's signature. Your child(ren) may arrive at the site after school dismissal. Members must be picked up by 6:30 p.m. As a courtesy, we will call your child using our PA system.

Parent Visitation: All parents are welcome to volunteer or attend special events. However, for safety reasons, you must complete a volunteer form, and we will conduct a background check. No one can pass through the glass doors without the proper documentation.

**Personal Belongings and Clothing:** Closed-toe shoes are needed when your child(ren) participates in any athletic or outdoor activities. The Boys & Girls Club of Weslaco Inc. is not responsible for lost or stolen articles. If a possession is valuable, we recommend that your child(ren) leave it at home. Found articles will be kept at the site for up to two weeks, after which time, any unclaimed items will either be donated or thrown away.

CLUB HAS NO TRANSPORTATION/ Transportation: If IDEA provides transportation, it is a privilege, not a requirement. All ineligible students riding on a space-available basis must ride the assigned bus and will be on a zero-tolerance conduct status. There will be no exceptions. Zero tolerance means if the student gets one safety report for breaking the bus rider policies, they cannot ride the bus for the remainder of the school year. This policy applies to any Boys & Girls Club members transported to our Club sites.

# **Discipline and Guidance**

\*\*Discipline and Guidance: \*\* The Boys & Girls Clubs are dedicated to supporting kids, understanding that they occasionally exhibit typical behaviors such as pushing, shoving, or arguing. We aim to create a wonderful experience for your child(ren) and maintain a "Positive Place for Kids." We have established Club Guidelines that outline major conduct violations. Please take a moment to review these guidelines with your child(ren). Our staff will implement the following rules:

Smoking Confiscate the items and call the parents.

• Drugs or Alcohol Confiscate the items and call the police.

• Weapons PERMANENT SUSPENSION

• Disrespect toward Staff of Volunteers First Offense – time out

Second Offense – parent notification and one-day suspension

Third Offense – Immediate 3-day suspension and meeting with parents

• Fighting (Physical, kicking, biting, hitting, etc.) Not seen by staff – time out for all involved

Seen by staff – There will be an immediate 3-day suspension for all involved and

meeting with parents.

Play Fighting
 Play fighting is dangerous and will be treated as above.

Ignoring Suspension

If a child returns to the site on the day of suspension and the parent fails to pick

up the child, an extra day of suspension will be added.

# The member will be suspended in-house if a Parent cannot be reached. And suspended from the Club for one or more days.

<u>Suspension of Membership:</u> The Boys & Girls Club of Weslaco Inc. Our primary responsibility is to ensure the safety and well-being of all members who engage in activities and programs at our facilities. To uphold this commitment, we maintain the right to deny access to any individual using our sites, programs, or activities if their conduct raises concerns.

Specifically, any member, parent, or guardian who has been accused of serious offenses, including assault or sexual misconduct, will be prohibited from attending or visiting any of our Club locations. Furthermore, if a member is currently on probation due to such offenses, their membership will be suspended, and they will not be permitted to participate in any activities or access any Boys & Girls Club facilities. We take these measures to foster a safe and secure environment for everyone involved.

## **Policies & Procedures**

Culture of Safety: Boys & Girls Club of Weslaco continually updates robust safety policies, programs and training for staff and volunteers to promote child safety and protect young people from threats in our society. These resources include but are not limited to:

- Child abuse Prevention Policy
- Prohibition of Private One-to-One Interaction Policy
- Supervision and Facilities Policy
- Drug-and Alcohol-Free Workplace Policy
- Incident Management Policy
- Technology Acceptable Use Policy
- Transportation Policy
- Emergency Operations Plan Policy

Safety Policies: The Boys & Girls Club of Weslaco keeps comprehensive safety policies that protect youth, including, but not limited to, policies on supervision, transportation, communication, and the prohibition of one-on-one contact.

24-hour Toll-free Child Safety Hotline: We encourage all staff, members, and families to report any incident or situation they feel is unsafe. Through our national partnership with <a href="Praesidium">Praesidium</a>, one of the nation's leading safety experts, Boys & Girls Club of Weslaco members and staff have access to a confidential 24-hour toll-free Child Safety Hotline at <a href="Medical-Bellow-Praesidiuminc.com">866-607-SAFE</a> (7233) or <a href="SafeClub@Praesidiuminc.com">SafeClub@Praesidiuminc.com</a>.

### **SUPERVISION**

Boys and Girls Clubs (local name) is committed to providing a safe environment. All Club activities and program spaces shall always be under continuous supervision by sight or sound (for restroom supervision) by a suitable adult staff (18 or over). To ensure proper supervision, staff and volunteers:

- Must abide by the prohibition of private one-on-one interaction policy.
- Must abide by all the organization's disciplinary policies and procedures.
- Must ensure that at least one adult staff (18 and over) is present when supervising members.
- Must always keep proper supervision ratios.
- Must be trained in proper supervision tactics and behavior patterns.
- Must ensure that all youth staff and volunteers are supervised by an adult (18 and over) staff member.
- Must at once notify Club leadership and give written reports detailing supervisionissues, accidents or critical incidents.
- Must never use electronic devices such as cell phones, PDAs, or other communication devices while supervising members unless for Club purposes, as defined in the Acceptable Technology Use Policy.

#### **EMERGENCY OPERATIONS PLAN**

- Fire
- Weather (tornado, flooding, hurricane, etc.)
- Lockdown (for interior or exterior threat)
- Bomb threat
- Suspicious package
- Training/drill schedule and reporting procedures for staff, volunteers, and members.

State and Local Laws: We comply with federal, state, and local safety laws, including those that affect facilities and vehicles.

Safety Partnerships: Nationally, Boys & Girls Clubs of America works with leading experts in safety, security, and technology to develop state-of-the-art solutions for Clubs. Partners include:

- National Child Safety Advisory Task Force, made up of leading experts and organizations
- Blue Ribbon Taskforce, composed of local Club leaders who provide input on safety direction and key safety initiatives
- Mental Health First Aid, a national program that teaches skills to recognize and respond to signs of mental illness and substance abuse
- Crisis Text Line, a confidential text message service for youth in times of crisis

Locally, the Boys & Girls Club of Weslaco partners with:

- Weslaco Police Department
- Weslaco Fire Department
- Weslaco City Department

Continued Commitment: In July 2020, Boys & Girls Club organizations voted to adopt additional safety measures to improve safety within our Clubs. Though many of these practices were already commonplace across our Movement, this vote made them mandatory for all Clubs. These include more stringent reference and background checks, enhanced Safety Committee requirements, more robust communication of essential safety resources and information, and more. With an unprecedented majority, on July 26, 2021, local Boys & Girls Clubs voted in record numbers to adopt additional membership requirements that further enhance child safety, implementing recommendations from RAINN that began in 2020 and will continue over the next two years - a demonstration of our continued commitment to keeping kids safe.

Nationally, Boys & Girls Clubs of America has advocated for passage of the <u>U.S. PROTECT Act</u> to improve background screening systems and access. The national organization has also partnered with the <u>FBI</u>, the <u>National Center for Missing & Exploited Children</u>, and the <u>Centers for Disease Control</u> to support the development of safety practices that benefit ALL youth-serving organizations.
