___ **Personal Belongings**

All personal belongings brought into the Club by a youth are the responsibility of that youth. The Boys & Girls Club is NOT responsible for lost, damaged or stolen items. Please discourage your child from Bringing anything to the Club that is not completely necessary, cell phones, ipods, money, portable game Systems etc. Necessary items, such as backpacks and jackets should be clearly marked with the Member's name. Items that are not collected from our lost-and-found in a timely fashion will be donated to a local charity.

___ **Membership Cards**

ONE membership card will be provided to each new member and renewal member when all application requirements have been met. Members should bring their card to the Club EVERY DAY. If members do NOT have their cards, certain privileges to program offerings may be denied. If a Club card is lost, a replacement fee of \$5.00 will be charged.
