# City councillors in dramatic U-turn

# Silver Strand site OE TEZOMEO

City Councillors, meeting behind closed doors, agreed in a dramatic turn-around last night to re-zone land near Silver Strand for the highly controversial Ward.

The site chosen for the facility is located to the left of the road leading down to the beach at Silver Strand. It was the original choice for hardstand over two years ago but deemed unsuitable at the time by the Corporation — a detailed agreement was thrashed out then between City Councillors who decided that hardstands would be spread evenly throughout the city in each ward.

The controversy escalated as hardstands came into service in all wards except the South Ward, and the choice of potential sites in the Salthill-Knocknacarra-Taylors Hill areas became increasing difficult. City Councillors from outside the South Ward insisted that the agreement had to be honoured. while it was claimed that the facility would damage tourism in the area.


Before Christmas, most attention centred on a site at Knocknacarra Cross owned by the Church, and a site closer to the main road up from Silver Strand known as Jackson's Field. Residents Associations in areas adjoining Knocknacarra Cross mounted a huge campaign against the site in their locality and threatened court action against its installation there, forcing Councillors, in effect, to back away.

Now Councillors have come back to their original choice, despite the fact that Corporation officials pointed out that there could be drainage difficulties with the site. The Draft City Development is being amended to allow for the rezoning and in effect has been

### Corpo work on pitches creates a fixtures crux

The Galway FA have called on the Corporation to ensure that alternative pitches be provided over the next month following the move by the local authority to carry out re-sodding work on four of the busiest soccer grounds in the city.

Re-sodding and pitch maintenance work usage in a couple of weeks," he added. have been carried out by Corporation workers Fahy's Field — rendering the grounds unplayable for up to a month in some cases.

However a spokesman for the Galway FA development in the city. said that the pitch work, coming as it does in the height of their playing season, will leave them in severe difficulties relating to the playing off of their matches.


