Board agreed that would be acceptable and no motion was needed due to the small amount.

The bark art banner needs to be changed. It currently says the 1st Annual and needs to be changed to the 2nd Annual. After the change Bark Art will be ready to go for the show this year.

The Pasco grange has been reserved for the Christmas party this year.

There was a discussion on combining the accounts to make tracking finances easier. A motion was made to combine all Gesa accounts into checking, saving, and the Edward Jones account excluding the Fast CAT account and the Junior scholarship account by Linda K. Second by: Denise. Motion carried.

New Business: The 3 Rivers Bird Dog Club reached out and was interested in doing a Fetch Dog trial at our show. They were wanting to use some of the area by FAST CAT that would not be needed and would provide their own volunteers and run the trail themselves, we would just be providing the space. The board was receptive to the idea and if approved by AKC the information about the trail will need to be sent to RKC by June 4th to be included in the premium list.

BEWARE OF PHISHING SCAM!

There have been Phishing emails being sent to RKC members claiming to be Cindi McInturf. The email states that Linda is having issues paying a vendor and ask that you assist with making the payment. IGNORE THESE EMAILS AND REPORT AS SPAM OR JUNK. Cindi would never send an email to RKC members asking for access to accounts. If you unsure if it was sent from Cindi or any other RKC member, call the person in question to verify. Additionally, check to see who the actual sender of the email is by checking who it is "from".

More information below about what "Phishing" is, shared by Stacey Davis & the American Whippet Club:

"Phishing" scams, emails impersonating a trusted source, such as a board member, are on the increase.

A "phishing" scam, often targeting people associated with non-profits and charitable organizations, is a fraudulent email or message that appears to be from a legitimate source, like an organization's member, board officer, or even the organization itself, designed to trick people into clicking malicious links, send money, download harmful files, or reveal sensitive information like login credentials or bank details, ultimately aiming to steal money.

Signs You're Being Targeted by a Phishing Attempt

- 1. Comes from a suspicious email address. Occasionally, an attacker will gain access to the email credentials of the person they plan to impersonate, enabling them to send phishing emails from the victim's real account. However more often, phishing emails come from an address that does not belong to the purported sender. Be sure to check the sender's email address not just the display name by either clicking "Show details" (Gmail), hovering over the sender's name (Outlook), or clicking the sender's name (Apple Mail).
- 2. Demands a sense of urgency in completing the request (e.g. today, in the next hour, by end of day, "I'm in meetings all day, please respond"). If the requester is pushy and insistent in tone, it's a clear indicator they're a threat actor.
- 3. Asks for money, gift cards, login credentials, or other sensitive information to be submitted to the requester or a third-party recipient or filled in on a web form. When money is requested, the message may claim the funder will be reimbursed at a later time.
- 4. If the message purports to be from someone you know (e.g. a board member or officer) but seems out of keeping with their usual voice or the types of requests they would typically make, stop and question whether the message may be fraudulent.
