Handling Class COVID 19 Protocol At 4PAWS

- 1. Please comply with all masking/face covering and social distancing guidelines.
- If you feel ill, OR HAVE COME IN CONTACT WITH SOMEONE WHO HAS TESTED POSITIVE, PLEASE stay home and stay safe. Follow the current CDC guidelines for quarantining.
- 3. PLEASE DO NOT congregate near the entry or any of the exits to the building.
- 4. Instructors will be taking attendance to minimize contact points.
- Hand sanitizer is located on the front desk and at various places around the facility. Please use it as appropriate.
- 6. Bathrooms will be available. PLEASE WASH HANDS AND/OR USE PROVIDED SANITIZER WHEN FINISHED.
- To further encourage distancing, parking spots may be marked off in the lot so that every other space is available. Overflow student parking in the gravel should approximate the distancing in the paved lot.
- 8. While we normally encourage families to attend classes, at this time, we will continue to allow only one handler with one dog. As soon as we can safely do so, we will relax this restriction.
- There will only be 8 chairs ringside for each active ring. The chairs shall be placed a minimum of 6 feet apart.
- 10. The matted working area features mats that are a little over 3' square. For moving exercises, teams will work in smaller groups or one at a time for distancing.
- 11. Each night, the cleaning folks will come in after classes and wipe down tables, chairs, door handles (and other utilized surfaces) and sanitize the bathrooms.

12. The mats will be sanitized weekly.

I first noticed her as I hurried by, volunteering time at our local animal control facility. I stopped to give her a gentle scratch under the chin, a little something that I reserve exclusively for the aged. Her coat, once lustrous, was dull and dry and she appeared quite thin. She wore no collar and had no microchip. No one seemed to know anything about this old dog. Her plight disturbed me. Was she there because of the death of her owner? Or had her owner been moved to a retirement home that excluded dogs? Was she abandoned because of her age, or the extra work and expense involved in caring for an aged animal? It was frustrating not to know the answer, for this was her last allotted day at the facility. No one had claimed her, this gracious old dog, carrying out her search, all the while maintaining her dignity.

Once again her beautiful eyes searched mine, and with a gentle wag of her tail, she stepped past me. I watched as others approached. If they did not notice her, she'd nudge their leg, look up into their faces, and then, with a sweep of her tail, move on, still looking for someone.

I so wanted her search to be successful, but that was not to be. The thought of that lovely old dog haunted me all day. Her plight wrenched my heart. I just could not leave her. So, with no hesitation, when I left that day, she came home with me. In our family, and in our hearts, there's always room for "Just One More".

CANINE HEALTH & CARE

Getting Rid of Skunk Smell

Thank you Cindi McInturf for submitting this excellent and very timely article idea for Canine Health & Care! Skunk mating season starts in February and who would have known that bathing your sprayed dog would seal in the smell? This information and recipe for treatment is reported to come from an animal control professional who swears it works.



The AKC site offers similar guidance but with the added ingredient of Hydrogen Peroxide. In considering the efficacy of non-water based treatment it is helpful to know that the spray from skunks is oil based, thereby dish soap and an enhancer like hydrogen peroxide is going to be a powerful combination for breaking it down.

Recipes that use tomato juice or Bloody Mary mix will simply "mask" the smell. These ingredients do not remove the skunk oil from the coat. Another consideration is where to apply skunk treatment. Your dog will be in misery and likely rolling and rubbing in an effort to get the skunk oil off. As a result it is safest to keep your dog from entering back into the house and apply treatment outdoors to protect rugs and furniture.

- 1. $\frac{1}{4}$ cup of baking soda.
- 2. 1-2 teaspoons of mild dishwashing detergent

like Ivory Snow.

- 1. 1 quart of 3% Hydrogen Peroxide solution.
- 2. Mix in a bucket and use immediately.
- 3. Work the foaming mixture well into the coat.
- 4. Leave on for five minutes.
- 5. Rinse with warm water.
- 6. Follow with dog shampoo if desired.

CAUTIONS:

- 1. Avoid your dog's eyes
- 2. Don't use a mixture greater than 3% hydrogen peroxide as it could cause burning.
- 3. Do not store left over mixure in a closed container—it will explode!
- 4. Hydrogen peroxide can bleach/lighten your dog's coat if kept on for too long.
