Subject: Cost Survey Analyses for Domestic Animal Waste

Rulemaking

Hello,

You are receiving this email communication because the State Board of Health (Board) is reaching out to a cross-section of businesses in Washington that work with domestic animals and may fall within the scope of the Board's rulemaking on domestic animal waste. We are inviting you to participate in a cost survey for this rulemaking project.

As explained in the attached cost survey, the state Regulatory Fairness Act, <u>chapter 19.85 RCW</u>, and Administrative Procedures Act, <u>chapter 34.05 RCW</u>, require cost analyses for significant rules. We are contacting many businesses with the hope that you will take time to consider the impact of the draft rule on your business and complete the accompanying cost survey. Such diverse businesses include horse stables, animal breeders, equestrian centers, livestock producers, veterinary clinics, animal hospitals, dog kennels, and other pet services.

The Board oversees many state rules and has been working to update its rule on Keeping of Animals, <u>WAC 246-203-130</u>, including a title change to Domestic Animal Waste. A copy of the Board's draft rule is attached for your information and reference. Like other state agencies, the Board is required to conduct certain analyses for such rulemaking. <u>We are not accepting formal comment on the draft rule at this time.</u> Public comment will be invited when these analyses are finished and are filed with the CR-102, Proposed Rule. You will be notified and invited to comment on the proposed rule when it is filed, published in the Washington State Register, and open for the formal comment.

In addition to sending this notice directly to hundreds of Washington businesses, we are including numerous associations ranging from kennel clubs to agricultural associations in this distribution, encouraging them to share this notice with their memberships. As such, please pardon any overlapping notices. Also, please feel free to share this notice among your peers to help spread word of this cost survey and rulemaking.

### What is the State Board of Health's mission?

Established in the Washington State Constitution in 1889, the Board is a policymaking body that offers a forum to engage people in the public health system, that develops environmental health and public health and safety rules, and that promotes

policies to protect and improve the public's health. Board authority is established in state laws covering a range of issues such as communicable disease, prenatal and newborn disease screening, drinking water, food safety, human remains, water recreation, animal waste, school environmental health and safety, and shell-fish sanitation.

## Why is the Board doing this rule?

Among other powers and duties, <u>RCW 43.20.050(2)(c)</u> charges the Board with unique responsibility and authority to adopt rules and standards to prevent, control, and abate health hazards and nuisance related to the disposal of animal excreta. <u>WAC 246-203-130</u>, <u>Keeping of Animals</u>, <u>serves as the Board's rule on the handling and disposal of animal excreta</u>, <u>or animal waste</u>. <u>Enforcement of the rule rests with local health officers</u>. This rulemaking aims to modernize rule language that now dates back nearly a century and to produce a simple rule with a few key health standards for the handling and disposal of waste from livestock and non-livestock animals.

## What's next for this rulemaking?

In November 2020, the Board approved moving forward with the rulemaking and filing the rule as a CR-102, Proposed Rule. As noted above, Board staff is now conducting analyses of the rule as required by law. When completed, the CR-102, Proposed Rule, will be filed and will be published in the Washington State Register. The Board will notify interested parties about the filing and details of the public comment period and public hearing. Following the public hearing the Board will decide whether to adopt the rule, or not. If the proposed rule needs material changes, the Board will need to repeat the steps filing the CR-102, receiving and processing public comment, conducting the public hearing, and deciding whether to adopt the rule.

## **Do Dogs Need Sunglasses?**

With temperatures starting to climb and the sun getting hotter and brighter what do we need to know about protecting our dog's eyes? This is a particularly important topic for those of us who have owned dogs with eye disease. The most painful decision in my life as a dog parent was whether to remove the eye of my 14 year old Yorkshire Terrier who had glaucoma in her left eye. It turned out to be an excellent decision as she lived to be 19 years of age and we had no problem getting used to her eye being permanently closed with a prosthetic.

Literature review about the effect of ultraviolet light on human eyes, clearly recommends use of UV protective sunglasses to prevent harmful radiation from the sun. Sun can damage the skin of the eyelid as well as the cornea, lens, and other parts of the eye. According to a recent article posted by the Mayo Clinic, UV exposure also contributes to the development of certain types of cataracts, growths on the eye and possibly macular degeneration (mayoclinic.org).

So what about dog eyes? Should we be shopping for well fitting UV protective Doggles this summer? There appears to be some on-line consensus that it takes a course of time for UV rays to cause enough cumulative damage to lead to serious eye disease such as cataracts. Because dogs don't have a long life span, they die from other causes before developing sun damage cataracts. We know that dogs do, in fact, develop cataracts but the etiology is identified as hereditary.

Sun damage is, however, identified with the development of a condition called "pannus." Pannus is defined as chronic superficial keratitis which is an immune mediated condition affecting the cornea or clear



part of the eye. Breeds more commonly affected include German Shepherds, Border Collies, Huskies, Australian Shepherds, Long-haired Daschunds, and Greyhounds but it can be found in any breed (vcahospitals.com). Pannus is basically a scar tissue response to sun damage that can lead to vision impairment and blindness. A first sign or symptom is "cloudiness on the very lateral edge of th cornea, and not only is it cloudy grey, there is also a tiny little blood vessel in it." (Dr. Steve Roberts, Veterinary Opthalmologist, quoted in rexspecs.com)

Another condition that can develop from sun damage to your dog's eyes is a surface ocular cancer called squamous cell carcinoma. According to (Case Reports in Veterinary Medicine, vol. 2012, Article ID 596593, 6 pages, 2012 https://doi.org/10.1155/2012/596593) the condition is "considered rare," however, some authors are reporting an increased occurrence of this tumor in recent years.

Other considerations for possible use of dog sunglasses is to protect from abrasion. Dogs who ride with their head out the window or in open vehicles (i.e., motorcycles) need to be protected from wind, dust, and debri. Dog breeds with large or prominent eyes (brachycephalics) tend to be more susceptible to abrasions, ulcers, and cuts just from running around the house and backyard so consideration for protective glasses is more recommended for French bulldogs, Pugs, and Pekingese.
