Beautiful Fall colors, bright clear skies, and another successful harvest to help feed the world are among the many positives to celebrate in November and

honor the time valued tradition of Thanksgiving.

So, why is it important to be thankful? Clinical psychologists have studied the power of practicing gratitude and found significant evidence that daily gratitude can improve positive thinking and help individuals maintain an upbeat mood in how they view life, others and themselves. Practicing daily gratitude, however, can be challenging as we are often inundated with negative news (i.e., politics, economy, and health issues). As a result, it requires making a personal effort to look for and mindfully note the positives that actually exist all around us.

Putting this practice into place in my own life has made a huge difference. The trick is in paying attention and thinking about how blessed we actually are. For example, just last month one of our dogs developed a left eye irritation with symptoms of mucous and a small early morning white discharge in the corner of his eye. Of course, the problem became noticeable right before we're supposed to be leaving for a dog show in Greeley, Colorado coupled with a vacation and being gone for two weeks. On the weekend our veterinarian's clinic is closed so we drove to the emergency pet clinic in Pasco. He was prescribed an effective eye drop medication that quickly cleared up the problem.

Not only were we grateful to have his eye problem accurately diagnosed and treated on a Saturday, a little mindful observation of the veterinary team opened our eyes to another whole level of medical service in our community that I had been taking for granted. Because our dog's health issue was not critical we waited most of the day and watched crisis after crisis come in for help. Dog parents from Walla Walla in tears because their dog was in acute kidney failure, a dog mom trying to stay calm as the team figured out why her dog was having seizures, over a dozen cats and dogs getting picked up and needing to understand special post-operative care instructions because their animal had just completed emergency surgery. It was intense and you could visibly see the fatigue on each of the vet techs and the veterinarian's face by late afternoon when their shift was ending. Despite the non-stop triage, treatment, and interface with upset pet parents, our dog received loving care, concern, and excellent treatment.

How blessed are we to live in a community with two emergency pet services available? There are no words when your animal is in need. So, for us, it only makes sense to include our dogs' amazing veterinary care givers on our holiday appreciation list. Cards, notes, photos, cookies or whatever way that we can all say thank you is so important as we support and appreciate the incredible veterinarians and veterinary care teams that work tirelessly to provide exceptional pet health care in our community.



Next year's shows will be RKC's 75<sup>th</sup> anniversary & suggestions for a theme were entertained.

**Judges Selection:** This year's Judges expenses was \$13,198.00. The judges' contract is being revised. Linda is still working on 2022's panel & invites suggestions from the membership. The 2022 GWP National will be held at our site.

**Match:** May 7 & 8, 2022 at Columbia Park. Sat: Match, including JS, 2 Fast CAT runs. Potluck picnic with WWKC. Meet the Breeds. Sun: 1 Fast CAT run.

Nancy Eby is also looking into possibility of a Clinic & Membership Outreach.

**New Business:** The small trailer is empty & there's still room in the big trailer for more supplies/equipment. Since the market is quite good for used trailers, Mark will bring a motion to the General Meeting to sell the small trailer.

#### **CANINE HEALTH & CARE**

#### CANINE EYE CARE

With all the forest fire smoke and extreme dry heat of last Summer, many dogs in the Pacific Northwest were identified as suffering with eye irritation according to two local veterinarians here in the Tri-Cities who were involved in the diagnosis, treatment, and aftercare of our Norwich Terrier who developed irritated eyes last September.

In order to prevent future eye irritation we explored over the counter products coupled with advise from our veterinarian to develop a daily canine eye hygiene program. Developing such a program can not only reduce tear stains, "eye boogers," and red eyes, but

really increase the comfort of your dog's eyes while reducing his/her risk for developing conjunctivitis.

At some point we have all had to wipe/ clean some gunky material from the corner of our dog's eyes. But what is considered normal or abnormal and



what causes this gunk to form in the first place? According to one on-line article by Kate Barrington, 2015, (https://www.petguide.com/health/dog/what-the-heck-are-dog-eye-boogers/) typical dog eye gunk is a combination of dirt, dust, and pollen. This makes sense given dogs are close to the ground and play in grass which makes their eyes susceptible to picking up foreign materials and possibly having some allergic reactions to all the pollens they come into contact with. A small amount of such discharge is considered normal and conducting daily or

weekly cleaning is not considered out of the ordinary.

A more current article by Adrienne Kruzer, 2021, (https://www.thesprucepets.com/eye-boogers-in dogs-5191293) identifies dog eye gunk as "rheum" which she defines as a mixture of tears, mucous, and dead skin cells that can be clear, white, yellow, red, dark brown, or black in color. Consistent with the Petguide article, small amounts are considered normal, however, large amounts or colors indicative of pus such as green or yellow are indicative of an eye problem.

Abnormal eye gunk may be a symptom of any of the following eye disorders which require immediate veterinary evaluation and care:

# $\sqrt{\ }$ Allergies $\sqrt{\ }$ Blocked Tear Ducts $\sqrt{\ }$ Dry Eye $\sqrt{\ }$ Conjunctivitis $\sqrt{\ }$ Eye Injury $\sqrt{\ }$ Glaucoma $\sqrt{\ }$ Tumor

Ruling out foreign debri is a reasonable approach to a first line home examination. Start by opening your dog's eyes wide using your fingers to hold his/her top and lower lids open with good lighting to detect any signs of hair, lint, or other foreign bodies in the eye. If possible, you may want to try and remove the debri via flushing with a buffered saline eye wash developed specifically for dog's eyes. (See product list below.) You may also want to try trimming and cleaning the hair around your dog's eyes to reduce further irritation.



If you are not comfortable with executing these types of interventions and/or

you are concerned of a more serious eye condition, consult with your veterinarian immediately. Your veterinarian will examine the pink, fleshy part around your dog's eye called the conjunctiva. Inflamed conjunctiva is indicative of an eye infection and will require antibiotic eye medication prescribed by your veterinarian.

Not only will your veterinarian check for eye infection, injuries, and foreign bodies, they will likely rule out blocked tear ducts which requires giving your dog a tear test to determine if they are producing sufficient tears. Some breeds are more susceptible to blocked tear ducts and according to "thesprucepets" other underpinnings can include allergens, debri, and tumor. Tear ducts are tiny pathways through which tears leave the eyes. If these little tubes become blocked, excessive eye boogers can result and treatment begins by flushing the tear ducts—a procedure conducted by your veterinarian.

More concerning problems include ruling out tumors and glaucoma. Glaucoma is diagnosed by measuring eye pressure and elevated pressures are extremely painful. Although glaucoma can cause excessive eye discharge it is not always evident. Veterinary examination is necessary to rule out this disorder.

These are some of the highest rated over-the-counter eye products on Amazon for developing a canine eye care hygiene program. However, <u>BE SURE TO CONSULT</u> with your veterinarian before starting or using any product in your dog's precious eyes!
