"We went to the Ventura Fairgrounds (where the fire camp was setup) with our dogs," Bersano said. "The firefighters coming off the lines and resting would pet them and talk to them."

Bersano said later, during the fire, her dogs got closer to the flames.

"My husband took the dogs up to the front lines," she said. "The firefighters on the front line were able to spend time with them then. There were firefighters from all over the country fighting this fire."

The dogs have also trained for and have served in other crises, Bersano said.

"There was a shooting at high school, so we took the dogs there," she said.

Bono and Harper have gone to colleges to visit with students wanting to de-stress during finals week.

"For freshman, their first time away from home, it's nice to help them try to adjust," Bersano said. "So we would just bring the dogs

and have them sit there, and the kids could visit with them."

Bersano said Go Team is not a business and that she doesn't get paid for the dogs' services.

When she moved to Walla Walla in 2020, she wanted to keep working with Go Team, and she learned they have a branch in the Tri-Cities. Bersano hopes to get her dogs involved in her new community and make connections that will allow her to put the dogs to work. Any group, organization

## The Battle With Dog Hair

Annual Spring Cleaning is a great opportunity to reduce dog hair and dander in your home which are a source of irritants to our lungs. In fact, regular and thorough dusting, vacuuming, carpet, and bedding cleaning are all good habits to maintain routinely in order to reduce the potential for allergic reactions to our pets.

Although some pet owners can build some tolerance to their dog's dander over time, guests coming to your home cannot which results in discomfort and sometimes a reduction in the amount of time spent with family and friends.



According to the American Lung Association and their on -line article, "Pet Dander," the American Academy of Allergy Asthma and Immunology has found that almost 62% of all households in the U.S. have pets, with over 161 million of those pets being cats and dogs. That's a pretty staggering number!

Other pets that make up that 62% include reptiles, amphibians and fish, which obviously don't shed but then there are homes with guinea pigs, rabbits, and hamsters which can also be culprits for allergies due to their shedding of dead skin cells just like dogs and cats.

Skin shedding is called "dander" which is a major underpinning to allergic reactions; however, allergies can also be triggered by proteins that are found in pet saliva, urine, and feces. What is particularly interesting, is that pet dander and other pet allergens can "linger in the air" and for longer periods of time than other allergens. What!! Why would that be? According to American Lung Association pet allergens are not only microscopic in size but they are also "jagged in shape" which means they can easily stick to fabrics. Yuck......

So, if pet dander is really super tiny can it really pack that big of a punch? It sure can particularly, if you already suffer with asthma or other respiratory diseases. Symptoms can include a runny or stuffy nose, sneezing, itchy or watery eyes, shortness of breath, and/or trigger an asthma attack.

Keeping your pet clean, your home clean, and creating pet free zones are all ways to combat pet dander. There are

medications that can be used such as antihistamines and decongestants and in severe cases, corticosteroids or leukotriene. The American Lung Association recommends talking to an allergist and getting an allergy test as the best means for developing a treatment plan.

Personally, I have not found a magic bullet for easily getting dog hair out of soft fabric blankets, furniture, or clothing. But.... Here a a few products that may improve your battle with dog hair. Please note, I do not endorse any of these products nor do I receive reimbursements, monies, or gifts from these companies. Just simply sharing some on-line research to possibly help us all in our battle with dog hair.

- 1. Half a cup of white vinegar added to the rinse cycle of your wash—acts as a natural fabric softener which helps to release stuck on dog hair.
- 2. Add laundry dryer sheets to your load (i.e., 3x Bounce Pet Hair & Lint Guard) which reduces static and allows pet hair to come off your clothes and collect in the lint trap.
- Non-toxic, reusable dryer balls that can be used in the washer and dryer but are more designed for catching long hair. Find them on Amazon—pack of 12—approximately \$10.
- 4. Fur Zapper—add to washer and dryer. \$10.99 on Chewy-3 star rating.
- 5. Allerpet dog dander remover (12 oz) bottle for \$9.95 found on Chewy. 4.5 star rating.
- HEPA Air purifiers can be found on Amazon. Large range anywhere from approximately \$100 to \$900. Different ratings and different room sizes they handle
- Bissell Pet Pro Cross Wave. Multi surface wet dry vac. Over \$400 with earlier models starting at just over \$200.
