The Richland Kennel Club (RKC), Inc. membership application process is as follows:

- The membership application needs to be filled out completely and returned in person at a RKC meeting or submitted via email to Richlandkc386@gmail.com.
 - Due to Covid the RKC meetings are presently being held via Zoom. Once your application is received you will be invited to attend a Zoom meeting.
 - General meetings are held the **first Thursday of each month at 7:00pm**, unless otherwise noted. Please note that some of these dates will fall on the Club's social gathering dates.
- Club members will sign the bottom of the application after it is returned.
- Candidate for membership must attend a meeting before the application can be read.
- Reading of the application process:
 - Application is read at a general meeting.
 - Application is read and reviewed at a board meeting and board makes motion to return it for approval to the general club membership.
 - Application is voted on at the next general meeting for acceptance in the Club. If accepted, payment of dues are as follows:
 - ✓ Dues are 10\$ for Junior (up to 18 years of age), \$15 for individual and \$25 for a family application.

CONSTITUTION		
ARTICLE 1, SECTION 3		
Name and Objects		
Section 1. The name of the Club shall be the Richland Kennel Club, Inc.		
Section 2. The objects of the Club shall be:		
a.	to further the advancement of all breeds of purebred dogs;	
b.	to do all in its power to protect and advance the interests of all breeds of purebred dogs and to encourage sportsman-like competition at dog shows and obedience trials;	
c.	to conduct sanctioned matches, dog shows and obedience trails under the rules of the American Kennel Club.	
Section 3. The Club shall not be conducted or operated for profit and no part of any profits or remainder or residue from dues or donations to the Club shall inure to the benefit of any member or individual.		
Section 4. The members of the Club shall adopt and may from time to time revise such bylaws such as may be required to carry out these objects.
