GENERAL MEETING MINUTES

RICHLAND KENNEL CLUB GENERAL MEETING RICHLAND COMMUNITY CENTER **NOVEMBER 6, 2025**

Called to order: By president Cindi McInturf at 7pm

Roll Call: 20 members, 2 guests

Minutes: Newsletter to be amended and remove the information claiming the meeting tonight was to be a pizza feed. The pizza feed was last month. Motion to approve as amended by Mark Eby. Second Teresa Carlon. Motion carried.

President Report: Cindi received the new Code of Sportsmanship and Civility. She passed the laminated poster around for club members to read. Cindi also wanted to let everyone know that AKC no longer wants credit or debit card information on applications sent via mail due to the risk of the information being stolen.

Secretary Report: Reported on correspondence.

Treasurer Report: Reported on accounts.

Committee Reports: Applications for Friday, Saturday, and Sunday have been submitted to AKC. AKC has given approval to start hiring judges for the show.

A motion was made to increase the show entry fee from \$35 to \$37 to cover the increase of AKC recording fees in the next few years by Stacey Davis. Second by Linda Riedel. Motion carried.

Cindi was able to talk to Jeremy regarding the golf cart check not being deposited. He said he needs to check with his wife and will get back to us.

Linda Kennedy and Denise Bostrom are working on getting judges for the show next year. If you have any suggestions for judges, please send them to Linda K or Denise.

Fast CAT: Chris Aberham gave a report of the Fast CAT trial from September. Everything for the trial has been finalized. There was a total entry of 495 and RKC's profit has been given to the new treasurer to deposit into the account.

Mark is putting together a proposal regarding the Fast CAT equipment that he will present to the board before bringing it to the general membership.

Membership: A motion to accept Caroline Smith as a member of the Richland Kennel club was made by Denise Bostrom. Second by Stacey Davis. Motion carried.

Elections: The new board was running unopposed and will be as follows:

A motion was made that the secretary will cast one ballot for the club officer election by Stacey Davis. Second by Mark Eby. Motion carried. New officers will fill their roles immediately. Thank you to Linda Riedel and Rosemarie Davis for serving on the board this past year, the club thanks you for your service.

Handling Class: Sit Means Sit has changed its name to Dogs R Us World. Laurie will follow up and see if we can still have class in their building starting in January.

Old Business: Discussed the issue of Quick Books charging \$70 a month to be able to have 3 registered users. It was decided that we would continue to pay \$70 a month to have the 3 users. Linda Kennedy is going to look into other programs that may be cheaper and able to do the same thing.

The Christmas party will be December 4th starting between 5:45pm and 6pm. Cindi has arranged for Toy For Tots to come and collect donated toys. For our animal charity Cindi suggested Might Meow Kitten Rescue. A motion to collect donated items for Mighty Meow Kitten Rescue for our Christmas party charity was made by Stacey Davis. Second by Rylee Carlon. Motion carried. Cindi will get a list of needed items and post it on the Facebook page.

A motion was made to authorized Cindi more money to purchase 2 bikes and a trike for Toys For Tots this year by Stacey Davis. Second by Denise Bostrom. Motion carried.

Cindi will be holding the Turkey Trot on Saturday November 8th and Sunday November 9th. She has received a lot of interest and should have a good turnout. There will be a \$10 registration fee that Cindi is going to donate to the trophy fund for the show next year. Valerie Brown suggested that instead of donating to the trophy fund that money be donated to acharitable cause. Cindi had already advertised the proceeds would be going to the trophy fund and did not think it would be good to change where the money is going to at the last minute. Future profits from FIT dog walks can go to charitable causes.

Discussed different charities that the club should donate to this year now that the club taxes have been paid and are up to date. The club normally donates to Take the Lead, The Canine Health Foundation, and a local charity. The club is looking for recommendations for local charities that could use our donations. One charity that was brought up was Little Lives Matter, they take in small animals like hamsters, guinea pigs, birds, and other small pets that need new homes.

Cindi looked online for some blocks and tire covers for the trail to help protect the new tires that we just had installed. She needed more information about the trailer to make sure she ordered the correct tire covers.
