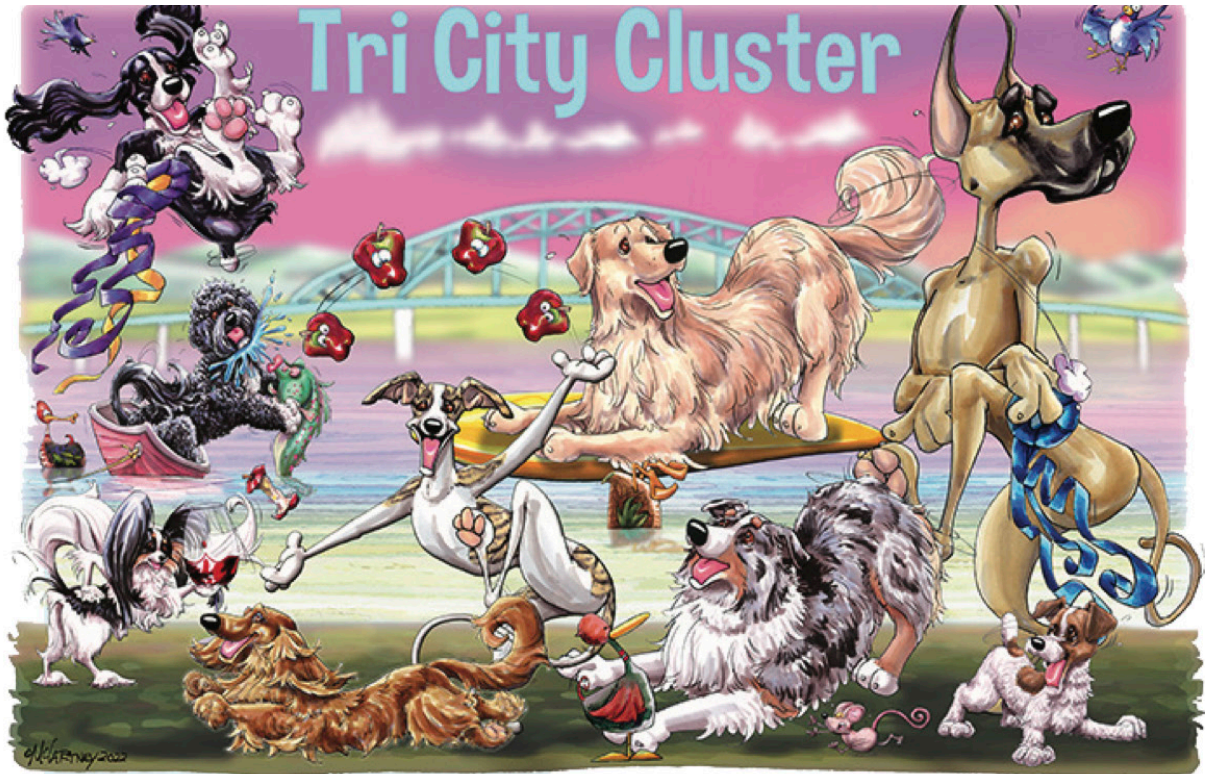

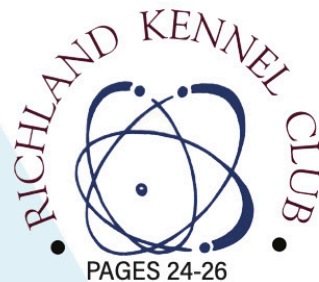

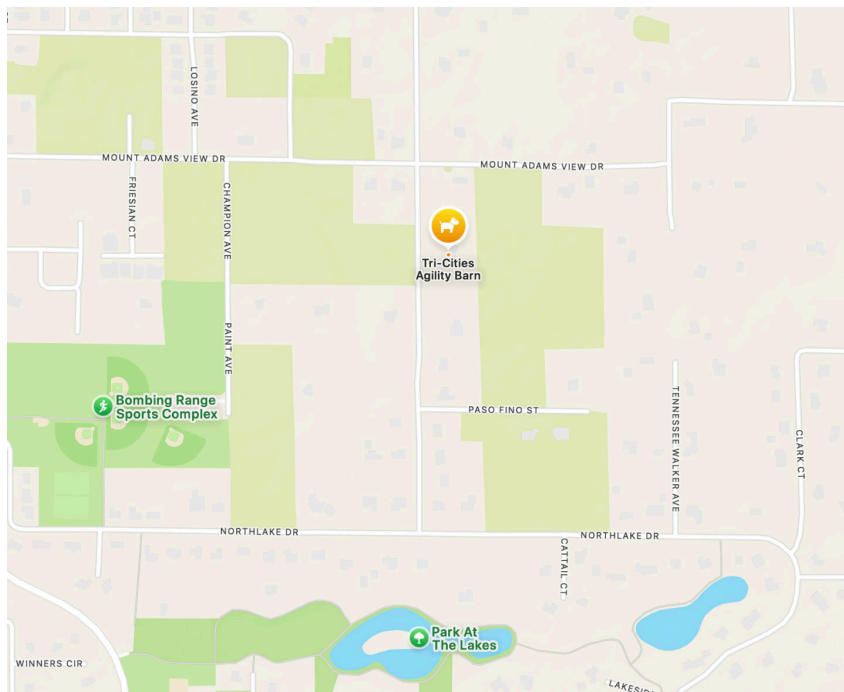

Roll Call: 16 members

Minutes: Motion to approve as published by Valerie Brown. Second by: Denise Bostrom. Motion carried.

President Report: The board meeting for September will be outside behind the community center where handling class normally is due to both the Library and the Community Center being fully booked. There will be a pizza feed at the October general meeting as well as president awards. Discussed AKC wanting to allow limited registered dogs to show in conformation classes at AKC shows.

Secretary Report: Received a refund from Liberty Mutual for insurance premium.

Treasurer Report: Report of accounts

Show Committee Reports: FAST CAT will have a meeting on September 9th at 7pm at the Richland Library. There will be a total of 5 trials for the weekend and the trials are filling up fast. We are just working out the final details. Fliers for the show have been made and will be passed out to the community. Linda Kennedy is offering a ring steward training on Friday September 12th at 6pm. There was a discussion on having enough funds in the checking account to cover the cost of the show. Motion to move money out of the Gesa money market account into the Gesa checking account and to close the Gesa money market account by Denise Bostrom. Second by Stacey Davis. Motion carried.

Membership: Motion to accept Jennifer Mora as a member of the RKC was made by Stacey Davis. Second by Denise Bostrom. Motion carried.

Handling Class: Handling class will be moving from the park to Linda Kennedy's agility barn for the month of October at 7pm. Class will move to Sit Means Sit in November with the time of class to be determined.

Old Business: Cindi gave an update on moving the 2026 show to the fairgrounds. She was able to submit the write up and all other information to AKC for them to review and approve. We are now just waiting to hear back on the approval. Judges selection is on hold until after we receive approval from AKC for moving the show location.

Nominations for the board have been submitted and will be sent out to the membership before the general meeting in October.

New Business: Cindi had some booklets made with the rules of the club to put in new member folders that can be handed out to new members so they have the information.
