Public Notice: ADVERTISEMENT FOR REQUEST OF BIDS

Notice is hereby given that; sealed bids will be received by the Borough of Ocean Gate, for the **Sealing of the Municipal Public Works Garage.**

Sealed bids for the above will be received up to 10:00am on March 18, 2026, by the Borough representative, at Borough Hall, 801 Ocean Gate Avenue, Ocean Gate, New Jersey, 08740.

The borough of Ocean Gate is soliciting bids to identify individuals and/or businesses qualified to supply and re-roof The Public Works Garage. A site inspection is required before any bid will be considered for acceptance; the Project consists of:

- Prep roof surface by pressure washing to remove all dirt and scrape any existing caulk/adhesive.
- Apply sealant to all fasteners and seems
- Apply commercial grade 100% silicone roof coating on entire roof at the rate of 115 gallons per 100 sq. ft.
- Replace all sky light panels with metal
- Replace all gutters on building (approximately 170ft.)
- Contractor is responsible for site maintenance during and at completion of project.
- All work must be performed in accordance with commercial grade sealer according to manufacturer's specifications and supply MSDS & warranty certificates.
- Minimum warranty on all products must be 10 years.

This request for bids is designed for those interested in creating a contract relationship with the Borough of Ocean Gate. All work on this contract must be completed within 30 calendar days from issuance of a Notice to Proceed.

All responses shall be contained in a sealed envelope addressed to the Borough of Ocean Gate, 801 Ocean Gate Avenue, Ocean Gate New Jersey 08740. Risk of timely receipt of mailed responses shall be upon the respondent. All responses mailed or delivered shall have the pertinent Bid item clearly marked on the outside of the envelope.

The right is reserved to reject any and all bids or to waive any informalities where such informality is not detrimental to the public interest.

Respondents are required to comply with the requirements of N.J.S.A. 10-5-31, et seq, and N.J.A.C. 17:27. Respondents are required to be registered with the State of New Jersey and provide a Business Registration Certificate issued by the New Jersey Department of Taxation, Division of Revenue. Each respondent must complete and submit with its bids a non-Collusion Affidavit and Affirmative Action Statement.
