RESOLUTION 2024-161 AUTHORIZING THE BOROUGH OF OCEAN GATE TAX COLLECTOR TO PREPARE AND MAIL ESTIMATED TAX BILLS IN ACCORDANACE WITH P.L. 1994 C.72

WHEREAS, The Ocean County Board of Taxation is unable to certify the Borough of Ocean Gate tax rate at this time and the Borough of Ocean Gate Tax Collector will be unable to mail the Borough 2024 tax bills on a timely basis; and

WHEREAS, in order to meet statutory obligations to the County and School Districts along with the sustaining Municipal operations in meeting its financial obligations, maintaining the tax collection rate, providing uniformity for tax payments and save the unnecessary cost of interest on borrowing, the Chief Financial Officer in consultation with the Tax Collector have computed an estimated tax levy in accordance to N.J.S.A. 54:4-66.3 and have both signed a certification attesting to the calculation;

NOW, THEREFORE BE IT RESOLVED, that the Borough of Ocean Gate Tax Collector is hereby authorized and directed to prepare and issue estimated tax bills for the third installment of 2024 based upon an annualized levy analysis totaling \$1,905,718.97. The Tax Collector shall proceed and take such actions as are permitted and required by P.L. 1994, c.72 (N.J.S.A. 54:4-66.3).

BE IT FURTHER RESOLVED, that in accordance with the law, third quarter installments of the 2024 taxes shall not be subject to interest until the later of either; August 10, 2024 or twenty-five days after the date estimated bills were mailed. Contained on the estimated bill shall specify the date on which interest may begin to accrue.

Councilman Cox explained that the 2024 Public Hearing on the budget was already advertised we are legally obligated to move forward with the public hearing tonight, therefore if anyone wants to make a public comment, they are welcome to do so but the budget has been rejected and an amended budget is being prepared. He suggests questions be held until the amended budget is introduced. As stated at the Council workshop on June 12, 2024, the 2024 budget that was scheduled for public comment this evening was rejected by the county due to numerous documentation and procedural errors. Once all the issues are resolved, the amended budget will be introduced, resubmitted to the county and another public hearing will be scheduled.
