1. The fee for the use of the Tennis/Pickleball facilities shall be \$25.00, per clinic or event, per day, per court for Ocean Gate residents and \$50.00, per clinic or event, per day, per court for non-residents. A security deposit of \$150.00 is due at the time the application is submitted.
 2. The applicant must submit proof (on the attached form) of liability insurance for \$300,000 and cover all activities. The Borough shall be named as an additional insured and be held harmless. The applicant will indemnify and hold harmless the Borough of Ocean Gate and its officials, employees and volunteers.
 3. The applicant will be responsible for any damages by malicious or rowdy activity by persons attending the clinic or event and will be deducted from the security deposit. Upon inspection by the Borough, the security deposit, or portion thereof, will be returned to the applicant.
 4. The event organizer must have a valid Ocean Gate beach badge or Ocean Gate recreation badge. All other clinic or event participants need not purchase a badge.
 5. Hours available for clinics or events are Monday to Sunday, 1:00 – 5:00 PM. Clinics or events are limited to two (2) consecutive days. Each court is subject to the fee listed above for each day of the clinic or event.
 6. Proper attire is required to ensure safety of players and the courts. SNEAKERS only on the courts.
 7. Children under the age of 12 must be accompanied by an adult.
 8. The courts are for the play of Tennis or Pickleball ONLY.
 9. All posted rules apply to clinics and events.
 10. The courts MUST be cleaned and returned to the original condition. All garbage must be placed in the appropriate trash receptacles.
 11. In the case of inclement weather, the Borough reserves the right to cancel or close the courts for safety reasons.

The applicant specifically agrees that this Indemnification and Hold Harmless Agreement shall include the responsibility to provide legal defense for the Borough of Ocean Gate for any suit arising out of the applicant's use of the premises, and that should the applicant or the applicant's insurance carrier fail or refuse to provide such a defense, the applicant will reimburse the Borough of Ocean Gate for any costs incurred by it for any person or organization acting on it's behalf.
