Ordinance # 503-05

All pet owners and keepers are required to immediately and properly dispose of their pet's solid waste deposited on any property, public or private, not owned or possessed by that person. In addition, all pet owners and keepers are required to have in their possession at all times while walking their pet such equipment, container, utensil, or receptacle necessary to move or remove pet solid waste from where it is excreted or deposited by the pet to a proper disposal receptacle or container.

Dogs on Beach

Ordinance #125,sec 4

No person shall have, take, permit or allow any dog, either on or off a leash, on any boardwalk, beach, pier or in water of the Toms River adjacent to any boardwalk, beach or pier.
