A RESOLUTION OF THE BOROUGH OF OCEAN GATE ADOPTING THE OCEAN COUNTY MULTI-JURISDICTIONAL ALL HAZARD MITIGATION PLAN

WHEREAS the Borough of Ocean Gate recognizes the threat that natural hazards pose to people and property within Ocean Gate; and

WHEREAS the County of Ocean has prepared a multi-hazard mitigation plan, hereby known as Ocean County Multi-Jurisdictional All Hazard Mitigation Plan 2025, in accordance with federal laws, including the Robert T. Stafford Disaster Relief and Emergency Assistance Act, as amended; the National Flood Insurance Act of 1968, as amended; and the National Dam Safety Program Act, as amended; and

WHEREAS the Ocean County Multi-Jurisdictional All Hazard Mitigation Plan 2025 identifies mitigation goals and actions to reduce or eliminate long term risk to people and property in (local government) from the impacts of future hazards and disasters; and

WHEREAS adoption by the governing body of the Borough of Ocean Gate demonstrates its commitment to hazard mitigation and achieving the goals outlined in the Ocean County Multi-Jurisdictional All Hazard Mitigation Plan 2025.

NOW THEREFORE, BE IT RESOLVED BY THE BOROUGH

Section 1. In accordance with (local rule for adopting resolutions), the governing body of the Borough of Ocean Gate adopts the Ocean County Multi-Jurisdictional All Hazard Mitigation Plan 2025. While content related to Ocean Gate may require revisions to meet the plan approval requirements, changes occurring after adoption will not require Ocean Gate to re-adopt any further iterations of the plan. Subsequent plan updates following the approval period for this plan will require separate adoption resolutions.
