This upper pasture is the ONLY pasture that does not flood so this construction project will directly impact the horses and their owners who use this area 24/7/365. The health and safety of the horses is also a concern.

The events that could be held here will increase area traffic, create noise pollution (from vehicles, microphone noise, music, etc.), light pollution, litter, and the loss of impervious land will only increase the flooding problems for the park and adjacent neighborhoods. This will negatively impact everyone in and around the park with the noise and increased traffic on a regular basis. Tanglewood is not, nor should it be, a fairground.
