

Dante Club Members, in good standing, are entitled to the following benefits:

1. Benefits for the death of a Member:			
a) The family of the deceased will have the option to either receive 15 meals delivered to their home (only available between the date of the member's passing and the date of the funeral) or the equivalent wholesale value of the gifted 15 meals to be deducted from the deceased's funeral luncheon provided by the Dante Club, either in-house or catered.	*		
b) If more than 15 meals are required, additional meals may be purchased at menu prices using the deceased's discount (maximum of 5%).	*		
c) The deceased's discount can be applied towards the funeral luncheon up to a maximum of 5%. (Cannot be combined with discount of spouse.)	*		*
d) The hall rental fee will be waived for the funeral luncheon.	*		*
d) A yearly mass will be planned in remembrance of deceased members.	*		*
2. Benefits for the Death of Immediate Family of a Member			
Hall rental fee will be waived for the funeral luncheon of the immediate family of a member. Immediate family members are spouse, parent or children of the member. This will also apply if the member is deceased.	*		*
2. Benefits for Members hosting event at the Dante Club:			
a) Any event a Member hosts at the Dante Club, the member will receive 1% discount on the food portion of the bill, per year of membership, up to a maximum of 5%.	*		
b) If the member's spouse is also a member, they can combine their available discount up to a maximum of 10% on the food portion of the bill. In the case of a funeral luncheon the maximum discount will be 5%.	*		
c) In the case of a wedding, if a member's child (bride or groom) is also a member they can combine the parent's and child's discounts to receive a maximum of 10% off the food portion of the bill.	*		
d) In the case of a wedding in which the bride and groom's families are both members of the Dante Club, the greater of the two family discounts will be applied to the total food portion of the bill up to 10%. Only one invoice will be processed per event.	*		
3. Benefits for Catering and Take-out orders:			
a) Discount of 5% on the food portion for orders over \$100.00, before taxes. Spouse discounts cannot be combined for catering.	*		
4. Activity Benefits:			
a) Bocciofila access/membership (not required for leagues participation)	*	*	*
