Bids must be placed by emailing the Pre-auction absentee bidder registration forms and Pre-auction absentee bid spreadsheet form to reshetter@gmail.com starting Saturday August 3, 2019 and no later than 5 pm on Tuesday August 6, 2019. Bids should give the Lot #, a brief description of the items and opening and maximum bids. No bids less than \$25 per lot will be accepted and the total bids for a bidder must exceed \$100. A maximum of 20 pre-auction bids is allowed per bidder. A CTTG member will place the opening bid and if there is a higher bid they will bid up to the maximum bid you have indicated, but only as high as is needed to win the item. Bid increments are determined by preset bidding regulations. The Pre- auction absentee bid spreadsheet is also available on the website. Save it, fill in your bids and email it to the above address.

Settlement: Settlement shall be at the conclusion of the auction August 10, 2019. Successful bids shall be billed to the provided credit card along with shipping and handling fees and a 7% buyer's premium via PayPal.
