Board Members Assignments:

Board member Connie Sweat motioned to appoint Matthew G Betts as Chairman. Board member Clinton Moon seconded the motion. All board members voted aye, and the motion passed.

Board member Connie Sweat motioned to appoint Chet Clayburn as Co-Chairman. Board member Clinton Moon seconded the motion. All board members voted aye, and the motion passed.

Board member Chet Clayburn motioned to appoint Connie Sweat as Treasurer. Board member Clinton Moon seconded the motion. All board members voted aye, and the motion passed.

RWAU Annual Conference:

Board Members Trainings:

The river crossing permit is ready. The drawing is done as well, they just need to meet with Stan Young. They will then submit it to the contractor.

Change Order for the Utahn Pipeline and Tank:

Board member Clinton Moon made the motion to approve Change Order #10: Irrigation line repair. Connie Sweat seconded the motion. All board members voted aye, and the motion passed.

Board member Clinton Moon made the motion to approve Change Order #11: unmarked water line repair. Chet Hansen seconded the motion. All board members voted aye, and the motion passed.

Change Order #12 was not approved at this meeting. Jason Broome from Forsgren Engineering will contact the county to see if they have some riprap that the district can use.

Discussion & Consideration of Working with Sunrise Engineering for the purpose of Lead and Copper Removal:

The application for Sunrise Engineering is done for the purpose of investigation of lead and copper in the pipelines in our district.

Safe for the Office:

There was discussion on getting a safe for the office. Nothing was determined. Board member Chet Clayburn stated that if the office needs to get one then they should. Board member Connie Sweat does not believe one is needed.

Bill Forgiveness:

It was determined that the customers who had a house fire just before Christmas will not need to pay the water bill until they can rebuild their home. Board member Connie Sweat motioned to have a bill forgiveness for the family that lost their home. Chet Hansen seconded the motion. All board members voted aye, and the motion passed.

Board member Clinton Moon motioned to approve all the new applications that have been corrected. Chet Hansen seconded the motion. All members voted aye, and the motion passed.

Update from District Manager:
