## VI. Committee Reports/Updates:

- Updated the membership levels with the new names, items, and pricing.
- Yard signs and ponchos will be available for individual sale for $\$ 20$ each.
- We will push for online memberships, not paper copies and checks.
- A QR code has been established for membership.
- Membership drive to take place at back to school nights at the middle and high schools and the first volleyball and football games.
- Sign-up Genius will be sent out for board members to volunteer for the membership drives at the previously named events.
- Mugs can be removed from the website as they are all gone.
- Approximately 48-55 blankets are left to sell.
- September 1: $1^{\text {st }}$ football game
- August $29^{\text {th }}: 1^{\text {st }}$ volleyball game
- Aug. 22 ${ }^{\text {nd }}, 5-7$ and 5:30-7:30 pm: back to school nights at the middle and high schools
- Concessions: Dawn P.
- Reviewed incomes and expenses.
- Added organizations to the spreadsheet so others can see the student groups that are benefiting from working the concession stands.
- Concessions will be taking over small swim meets at the HAC too.
- Groups are allowed to sign up for a variety of 3 events on a first come, first serve basis.
- Groups will make a min. of $\$ 100$, max. of $\$ 1,000$ working at the concession stand.
- Issue of reliability of wireless internet for the use of the Square card reader at the outdoor concession stand and some transactions not going through. Hoping to get the use of a more reliable device from the school district.
- Advertising: Lisa S.
- Working on the collection of sponsorships.
- $\$ 18,750$ in sponsorships so far, more to come. American Family will not be renewing their sponsorship on the football board, Muscatell hasn't sent a response yet. Midco is on the marquee and football signs, not sure of their contract expiration.
- Corporate sponsorships do include activity passes.
- $\$ 500$ for a sponsorship panel on the football board. Not sure who is responsible for paying for the actual sign-Packer Backers or the sponsor. Vendors to contact as options for signage include:

- Changing to 1-year contracts for sponsorships instead of 3-year. Tracking the duration of sponsorships has been difficult.
- 9 people have signed up for the digital board in the gym. Max. of 15 . $\$ 750$ for the year.
- Marquee: $\$ 2500$ for first year, $\$ 2000$ each subsequent year.
- Scheels will do promo items and events, no sponsorships.
- Activity passes, mugs, and decals to go out before the first games to our corporate sponsors.
- Lisa to send out a list of the advertisers to the Board.
- Discussed the possibility of having student groups/classes learn how to do the advertising on the digital boards. Steph has volunteered to continue doing it.

- Jamie Aasen will do the website updates. Kim to send meeting minutes to Jamie. Packer Backer donations to groups will also be posted on the website. Steph is verifying what should be publicly posted for our nonprofit status.
