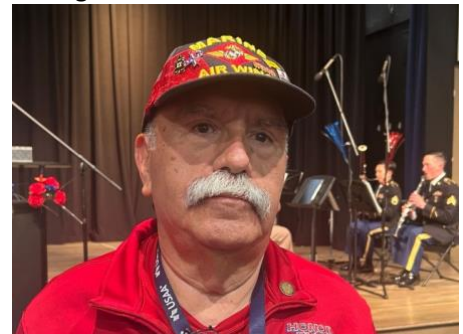

## VSO Dan Wood

MCL VSO Director has asked that we inform our Department/Detachments about a recent court ruling against a company that finally got caught illegally filing claims for veterans. Below is the brief statement about the case that was handled by our supporting Law Firm Bergman & Moore. If you would like to see the full description, let me know and I will forward the document to you.

The bottom line: The U.S. District Court for the Middle District of North Carolina has granted summary judgment in favor of the plaintiff Veterans on a key threshold question: Veterans Guardian VA Claim Consulting, LLC was acting as an unaccredited VA agent when it prepared and presented Veterans' disability claims for a fee, in violation of federal law. This is not a preliminary procedural ruling; it is an established finding of fact that will carry into the remaining proceedings. The court will decide the state law damages questions (North Carolina Unfair and Deceptive Trade Practices Act and Debt Collection Act) for a later order.

This is just one of the fraudulent companies out there screwing our Veterans by misrepresentation and scamming them for large amounts of money. So, IF you or another Vet you know of has been scammed by this firm or another one like it, PLEASE reach out to me to see what can/will be done on their/your behalf.

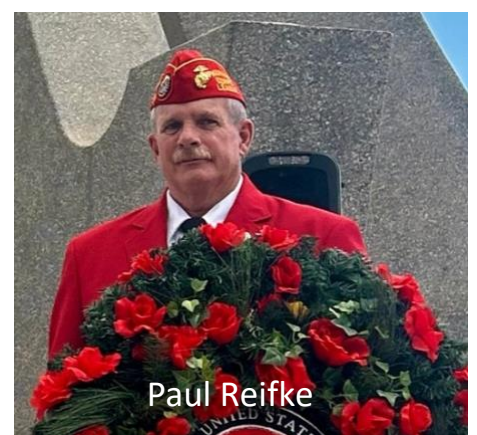
