## VSO Update by MCL VSO Dan Wood

HAPPY NEW YEAR MARINES! As we start this year I thought I would share some highlights and 2026 plans for all MCL VSO's that you, as MCL Members/Associates and all Vets might be interested in. Terry has offered to include any VSO articles to the MCL Newsletter as a way to help keep our members, and associates informed with all things VA Health care.

Here are some excerpts from the MCL National Director of Veteran Service Officers Phillip Du:

1. In 2026 the Marine Corps League National Veterans Advocacy Academy (VAA) Veterans Service Officer (VSO) Accreditation Training Course schedule, administrated by our training partner, Bergmann & Moore, LLC. This course is the official VSO accreditation training offered as a pathway for MCL members (regular & associate) who aspire to receive VA accreditation and become a MCL National VSO. It also supports our ongoing effort to build a highly trained and professional VSO corps.

2. Some of these efforts have already paid off. For example, from July to November 2025, our VSOs have now helped secure **over \$75 million in benefits** for veterans and their families. That figure represents real outcomes providing stability, care, and dignity for the veterans who place their trust in YOU.

3. We are pleased to announce the **2026 Marine Corps League National Veterans Advocacy Academy (VAA) Veterans Service Officer (VSO) Accreditation Training Course** schedule, administered by our training partner, Bergmann & Moore, LLC.

Should you be interested in knowing more about the accreditation processes you can go to the National MCL website, scroll down to find the VSO contact information and updates. While there please check out our **Statement of Representation** that we provide to each vet prior to accepting their request for representation. I fully believe that it clearly represents who we are as MCL VSO's.

Several weeks after the government shutdown, and subsequent re-opening, I was finally able to get my PIV card that gives me access to all VA Medical Records in the VBMS system. After a few more weeks working with the IT department, I had complete access to the system. Since then, on top of my already existing VSO workload, I am averaging 3-5 phone calls/emails a week from vets needing assistance with their health care needs and filing a claim.

I hope to bring you periodic updates, as time allows, to help keep you Detachment #29 members informed.

## **Marine Corps History for the Month of January**

### **Second Battle of Khe Sanh**

On January 20, 1968, the second battle for Khe Sanh began outside the village of the same name in the Quang Tri Province, Vietnam, 14 miles south of the DMZ and six miles east of the Laotian border, when the People's Army of North Vietnam (PAVN) launched a massive artillery bombardment on the U.S. Marine garrison. For the next 77 days, until April 6, the Marines and their South Vietnamese allies, the Army of the Republic of Vietnam (ARVN), fought off the siege in what was the longest, and one of the bloodiest, battles in the war.

### **Operation Dewey Canyon**

On January 22, 1969, Operation Dewey Canyon, arguably the most successful high-mobility regimental-size action of the Vietnam War, began in the A Shau/Da Krong Valleys when the 9th Marines, commanded by Colonel Robert H. Barrow, and supporting artillery were lifted from Quang Tri. By mid-March, the enemy's base area had been cleared out, 1617 enemy combatants had been killed, and more than 500 tons of weapons and ammunition were recovered. Barrow later went on to become the 27th Commandant of the Marine Corps.

## **Annual Wreath Retirement for Wreaths Across America**



The annual Wreath Retirement for Wreaths Across America will take place at Pikes Peak National Cemetery on Saturday January 24<sup>th</sup> at 9 AM. This event is held rain, shine, snow, or cold and will conclude once all wreaths and winter decorations have been cleared from every section of the cemetery.

Volunteers are needed to help remove wreaths from headstones and columbarium, transport them to central pickup points along the cemetery roads, and assist with loading them into trucks or trailers for disposal in designated dumpsters. This is a meaningful community service project that helps maintain the cemetery's dignity and appearance. Dress for the weather and expect possible mud. Wear old clothes and gloves; pine sap is common when handling greenery.
