Under 18's

Under 18's are not permitted to book UV services via online or in store. Customers under the age of 18 are not permitted to purchase, attempt to purchase or attempt to utilise services relating to UV or use any of the UV services within our salons. Anyone who knowingly pays for services

and is then found to be under the age of 18, will not be permitted to use the services and will not receive a refund.

Refund Policy

Free Tan - Please note our free tan promotion is available in store only and is subject to change throughout the year. This promotion is available for new customers only unless specified. (New customers are defined as a customer who has not been registered with Leveche Tanning Itd before). Your free tan must be used within 14 days of registration, if this is not used it will expire on your account. Free tan is only available on UV sunbeds. Free tan duration is based on an assessment of your skin type by our in-store tanning consultant but the maximum minutes allowed will be 9 minutes. The company has the right to refuse a free tan if the customer is already registered with Leveche tanning ltd and has registered a second account to claim a free tan.

Gift vouchers are valid for a period of 2 months from the date purchased. The date of purchase and the date of expiry is clearly stated on the front of the voucher.
