## Utilities & Equipment

- Food vendors may request electricity; space and access are limited and must be requested in advance. While we will make every effort to accommodate, electricity is not guaranteed.

## Vendor Selection & Priority

- Greater Athens Chamber of Commerce members will receive first consideration and placement priority.
- All vendors are subject to approval by the Greater Athens Chamber of Commerce.
- Upon approval, vendors must remit payment in full to secure their space.
- Reservations are not confirmed until payment is received.
- No refunds will be issued for this event under any circumstances.
