Welcome Letter from the President Elect

Dear TEFL Kuwait World,

At IATEFL Associates Day in Belfast last May, Rana and I presented our fledgling TEFL Kuwait in a large hall with three stages. We took center stage and told our story: how we started in the pandemic as a local organization but became global overnight, much to our delight. How it was teacher isolation and need for connection that sparked this lightning expansion. And how, emerging from zoom back to in-person, we had decided to stay completely free of charge – free membership, free events, free certificates. TEFL Kuwait, we decided, is and will remain pure service to educators.

That day, IATEFL officials nicknamed TEFL Kuwait "the baby on board," and one former IATEFL president was overheard saying, "TEFL Kuwait is my favorite Association."

Thanks to you all, we continue to climb. Reviewing proposals for this first conference of its kind in the MENA region spanning **Technology, Business, Education and Language**, words like fascinating, surprising, compelling and must-attend spoke to me. I kept hearing myself say "I can't wait to attend that!" Just now I posted in the Conference Committee chat: "You are the wind beneath our wings."

"Translanguaging, Multimodal Meaning and Digital Media: Recent Trends in Language Teaching and Learning"

Friday, February 10 – 9:30AM -10:30AM, Theater, G Building

This presentation will explore three recent trends in language education and their intersection: translanguaging, multimodal meaning, and the use of digital media in support of learning. Translanguaging approaches advocate the mixing of languages as part of the learning process bridging the forms of home language and everyday forms of meaning other than language (including for instance image, space, object, and embodied presence) to support language learning. In an emerging generation of elearning environments, digital media can readily represent multimodal meanings, and via embedded machine translation tools, support translanguaging strategies. This presentation will explore these emerging theories of language learning and illustrate their application in e-learning curricula and classroom contexts.

Abstract and Title: "Multilayer, Reflective Learning for the 21st Century"

The title of this TEFL Kuwait conference includes four domains: language, education, business and technology.

Bio:

Bill Cope is a Professor in the Department of Education Policy, Organization & Leadership, University of Illinois, Urbana-Champaign. His research interests include theories and practices of pedagogy, cultural and linguistic diversity, and new technologies of representation and communication. His recent research has focused on the development of digital writing and assessment technologies, with the support of several major grants from the US Department of Education, the Bill and Melinda Gates Foundation and the National Science Foundation. The result has been the CGScholar multimodal writing and assessment environment. With Mary Kalantzis, he has co-authored or co-edited: New Learning: Elements of a Science of Education, Cambridge University Press, 2008 (2nd edition, 2012); Ubiquitous Learning, University of Illinois Press, 2009; Towards a Semantic Web: Connecting Knowledge in Academic Research, Elsevier, 2009; Literacies, Cambridge University Press 2012 (2nd edition, 2016); A Pedagogy of Multiliteracies, Palgrave, 2016; e-Learning Ecologies, Routledge, 2017; and the two volume grammar of multimodal meaning: Making Sense and Adding Sense, Cambridge University Press, 2020.

Bio:

Dr. Thanassis Rikakis is the second dean of the USC Iovine and Young Academy (IYA) for Arts, Technology and the Business of Innovation. The IYA's mission is to empower a diverse generation of leaders, innovators and entrepreneurs through an integrated learning framework that cultivates the innate human abilities for complex unbridled creativity. Thanassis is also a professor at the IYA and a courtesy professor of Bioengineering at the USC Viterbi School of Engineering. He co-leads the USC Interactive Neurorehabilitation Lab. His research spans systems design, engineering and arts with a special focus on interactive neurorehabilitation, adaptive learning, experiential media and cyber-human intelligence. Before joining the Academy Thanassis served as founding director of the Calhoun Honors Discovery Program and director of the Calhoun Center for Higher Education Innovation. These initiatives focus on adaptive, transdisciplinary and trans-sector life-long learning. From 2015 until 2017 Thanassis served as executive vice president and provost at Virginia Tech. He led the development of transdisciplinary discovery communities (Destination Areas) and a new resource model (Partnership for an Incentive Based Budget) and co-led plans for the expansion of the VTC Health Sciences campus in Roanoke and for cross sector VT initiatives in Northern VA. From 2012 to 2015 he served as vice provost for design arts and technology at Carnegie Mellon University where he founded the Integrative Design, Arts and Technology (IDEATE) network. He has also served as founding director of the School of Arts, Media and Engineering at Arizona State University and Associate Director for Research and Development of the Computer Music Center at Columbia University. He has led gift efforts from philanthropy and industry totaling more than \$75,000,000. He has been PI or co-PI in research grants from NSF, NIH, NEA and industry totaling over \$16,000,000. He has authored 45 publications spanning computing, engineering, health, education, design and the arts. He has composed 30 original music compositions performed internationally. He remains an active teacher of undergraduate and graduate courses and research supervisor of graduate students.

The subtitle includes areas of knowledge that at least partially result from intersections of these domains (such as translanguaging, digital media and multimodal meaning) as well as high level skills (such as metaversity In doing so the conference recognizes the need for educational systems that leverage the unique human abilities for multilayered, hierarchical learning in order to address the complexity of the 21st century. This talk will discuss multilayered learning as being applied at the Iovine and Young Academy (IYA) of the University of Southern California. Over the past 10 years the IYA faculty, students and staff have worked with industry and community partners to develop a multilayered learning framework for integrated innovation with a focus on innovation at the intersection of technology, business, design and culture. The learning framework is producing graduates that are placed in strategic positions with top companies right out of school and launching highly impactful start-ups. The talk will present the framework and its outcomes and will connect the framework to related work in reflective thinking and reflective practice. We will close by proposing pathways that leverages the IYA experiment to help define generalizable and scalable reflective learning system that can address complex 21st century learning experiences and societal challenges. The talk has been prepared by IYA faculty Thanassis RIkakis and Doug Thomas and will be presented by Thanassis Rikakis, Dean of the IYA.

Abstract and Title "MetaVersity is the future of Education"

As educators, we must understand that the future of education is inextricably linked to the future of work. As our world continues to change and evolve, so too must our educational institutions. Metaversity is one approach that holds great promise for the future of education. In future, the Metaverse could be used to create realistic simulations of historical events or scientific phenomena. Students would be able to explore these simulations and learn through experience in a way that is not possible with traditional methods of instruction. The Metaverse has the potential to engage students in active learning experiences that are both fun and informative.

Staying cognizant of the fact that the COVID-19 pandemic has pushed the boundaries of all education institutions and tested new models of learning delivery that engaged the Gen-Z with more excitement about learning. This opportunity brought back all higher education institutions to the same reset line. More and more institutions are pioneering new technological tools to excite Gen-Z about online learning. This has resulted in having universities around the world at the same starting line, it created an opportunity to move from University to Metaversity.

Metaversity at its core is an integrated network of educational virtual worlds navigated via eye movements, feedback controllers, or voice commands. Its beauty lies in the fact that it feeds right into the cravings of the modernday learner. Imagine the authenticity of learning when plagiarism is combated with NFTs, and the knowledge is experienced not just accessed. The benefits of having your learning history over decentralized Buildingchains make learning secure and deceit impossible. In MetaClass, all contributors to course development may claim a stake in NFT, i.e. Instructor, Assistant, Content Developer, Graphic designer, Assessor, etc.

The Future of the Metaversity is tempting and offers an opportunity for a great reset. This is the time and space where we let our imaginations lead the way. The technology is here to stay, Let's build some real estate that doesn't leave behind ruins but an ever-existing experience in the ether.

Abstract and Title "The Quest for Academic Excellence in ELT"

Academic excellence is the demonstrated ability to perform, achieve, and/or excel in academic activities. Academic excellence for teachers has been identified with achieving superior performance and engaging successfully with activities related to teaching, scholarly output and service. For most of my teenage years and adult life I have been in the pursuit of academic excellence. Now as I am closing in on my golden years, I would like to share what I have learned about this topic and provide some strategies that I have found useful.

Bio:

Prof. Abdullatif Al Shamsi held the position of President and CEO of the Higher Colleges of Technology in 2015 as per Federal Decree (29) for seven years. He received his Ph.D. from Duke University, USA in 1997 and received his master and bachelor's degree from Boston University. In recognition of attainment against the UK Professional Standards Framework for teaching and learning, he earned a Principal Fellow (PFHEA) status from Advance HE UK in 2020. Previously, Prof. Al Shamsi was the Managing Director of the Institute of Applied Technology (IAT) for seven years, where he established Applied Technology High Schools, Fatima College for Health Sciences, and Abu Dhabi Polytechnic. He started his career at UAE University as assistant professor, then he was appointed an Assistant Vice Chancellor for Research. Later, he founded a university-wide Internship and Work Integrated Learning.

• Published more than 45 research in international peer-reviewed journals, presented 31 in international conferences, and authored 3 books, which lead to obtaining the Full Professorship Academic Rank.

• Participated as a Keynote Speaker in 28 local and international conferences.

• Published a Nature Research Article to be the rst globally reliable study of "The Detection Dogs Test is more sensitive than Real-Time PCR in Screening for SARS-CoV-2".

• Published series of articles in Harvard Business Review Arabia and other leading journals about contemporary issues in the led of Education.

Christine Coombe has a Ph.D in Foreign/Second Language Education from The Ohio State University. She is currently an Associate Professor of General Studies at HCT, Dubai Men's College. As a humanitarian activist, Alkhateeb lobbies for a number of critical humanitarian issues in Kuwait, most importantly the issue of Women's rights, Statelessness, expatriate conditions, and domestic workers conditions in Kuwait and the Gulf. Alkhateeb was a weekly columnist at *Alqabas* Newspaper, *Al-Jareeda* Newspaper, *Awan* Newspaper (all are Kuwaiti newspapers) and currently is writing a weekly column with *Al-Quds Al-Arabi* Newspaper (published in London) and *Alhurra* Newspaper (published in Dubai). Alkhateeb is a published Translator with the National Council for Culture, Arts and Letters in Kuwait.

Abstract and Title

"Justifying reflection as part of summative assessment"

Friday, February 10 – 11:15AM -12:15PM, B-205, Liberal Arts Building, B Building

Supporters of all things quantitative may tend to dismiss reflections as wishy washy and subjective. This is especially true in our world of objectivity and scientific measurement in education. This would suggest that reflection may have little role to play in standards and learning outcomes-based assessment. Yet reflection is identified as a higher end cognitive skill and if we want to assess students' ability to reflect, then we should assess it. This session aims to justify its use in assessment not only as evidence of this ability, but also as a powerful backwash tool for all stakeholders in the learning process. The session will start by defining the parameters of effective assessed reflection. I then provide a number of examples from my experience in both writing and assessing reflection. These examples will cover the assessment of language learners as well as trainee teachers, and will include one example of how reflection was used to replace summative assessment in lockdown where online discrete exams were the norm. Delegates can reflect on the session in relation to their own practice as learner and/or teacher, and how reflection may fit into it.

Bio:

In his 30+ year career Dr. Mick King has managed, lectured, tutored, taught, and trained (teachers) in both TESOL and Education. He has taught all levels of English, and taught education up to the post-graduate level across Europe and the Middle East. His own study has included education, TESOL, and educational management, and his service to the profession has involved TESOL organization board membership, and review work for journals and conferences. A Phenomenological Study of University Lecturers' Perceptions towards Assessment Literacy in Iranian Context

Room (A-104H)

This study examines the perception of the basics of Assessment Literacy (AL) by Iranian university teachers. Using targeted screening, 14 professors from 5 universities in Iran were selected to participate in semistructured interviews. The interviews with the participants were tape-recorded, transcribed and subjected to content analysis. The results identified two important AL areas: knowledge (e.g. having an acceptable level of digital AL, making assessment valid, ensuring tests are reliable and having a good level of pedagogical content), knowledge and skills (e.g. Involving students in assessment, using alternative assessment methods, using logically traditional assessment methods, informing students about test results, conducting tests in a standardized way, using valid assessment procedures and positive feedback). After discussing the results, the study concludes with a series of implications for different stakeholders and suggest some new horizons for further research. The results indicate that contextual factors strongly influence assessment training. Finally, the results show a significant correlation between the content of assessment training courses and teachers' perceptions of professional development needs. This could indicate that the more teachers learn about specific areas from language assessment onwards, the more training in assessment they feel is needed, indicating a gap in teachers&; awareness of their own AL

Well-structured Electronic Portfolio as a Facilitator of Engagement in EFL Skills Room (A-103)

The electronic portfolios have been widely accepted as the learning and assessment tool for enhancing language skills and competence in higher education. However, previous studies have not profoundly examined how e-portfolios with well-defined structure influence students' engagement. More information on e-portfolios and engagement are also needed. Therefore, this study is conducted to investigate the well-structured e-portfolios on students' engagement in learning activities as these activities consisting of self-and peer-assessment. To server this intention, an explanatory sequential mixed method including questionnaires and interview was adopted to obtain data, questionnaires and reflective notes were analyzed using descriptive statistics and the qualitative thematic analysis technique respectively. The findings showed that there is no difference among EFL students' perception to language skills. It was also indicated that self-assessment plays essential role in engagement which informs constructs of e-portfolio. The Use of Instructional Games in Teaching Grammar Room (A-104H)

This paper reports on a quasi-experimental study that examines the use of instructional games in teaching grammar, and in particular, it explores the effect of tic-tac toe and board game on the present continuous and present simple. The study was conducted among 60 (N=60) Moroccan EFL common core students from two different high schools in Casablanca. All the participants took a pre-test prior to instruction and a post-test immediately after the training, which lasted three sessions. The experimental group (n=30) were instructed using instructional games, mainly tictac toe and board game. However, the control group (n=30) received no treatment. The experimental group was also given a feedback questionnaire at the end of the training. The data sets were submitted to SPSS, using the Independent T-test. The findings indicated that all the participants were equal in the pre-test. Nonetheless, the experimental group outscored the control group in the post test. Can Self-Constructed Visualization (SCV) Meet Unique Mathematics Learning Needs of Students with ADHD?

Room (A-106H)

Attention deficit hyperactivity disorder (ADHD) is one of the major problems in the field of education. Children with this condition may also have complex learning disabilities, such as dyslexia or dyscalculia, that affect their capacity to learn and their overall wellbeing. Specifically, children with these disabilities often experience difficulty learning mathematics. Children as young as 3 - 6 years old can be diagnosed with ADHD and it can affect 5.29% of school-age children. This study's first aim is to help students with ADHD by demonstrating how such students can answer mathematical word problems by using passively received visualisation (PRV) and self-constructed visualisation (SCV). PRV refers to when children use given images of objects to help visualise word problems, whereas SCV refers to when children create their own images and drawings to visualise word problems. The second aim of the study is to provide recommendations regarding how best to help students with ADHD in terms of achieving educational objectives. The study aims are acheived through examining how using visualisation to answer mathematical problems can improve the learning of students with ADHD.
