## **AGENCY PRESENTATION: Kitsap Regional Library: Supportive Library Services** – Jason Driver, Kitsap Regional Library Director

Jason joined KRL in 2022, coming from a career in social services and the Chicago Public Library. KRL has about 185 staff across nine library locations and mobile services in Kitsap County.

Public libraries are de facto day shelters and severe weather shelters for homeless community members. Libraries are publicly accessible and open to all, even without a library card. Once people are in our spaces, we see other needs arise, including lack of housing, mental and physical health issues, low incomes, and more. For the most part, the library is not seen as a government entity, so people feel more trusting of library staff than they would at other social service locations. We are a safe space for all ages and try to meet people where they are.

In 21<sup>st</sup> century libraries, we need to stay nimble, figure out where our gaps are, and identify how to/who can fill them. We offer more than just books: digital resources are booming, we serve as multiuse spaces, do outreach to community settings, help access online services and apply for jobs and benefits, navigate local resources, and more. We also offer free wifi, computer use, printing, and meeting spaces.

We have information professionals available to help connect people with resources they need. Library staff aren't necessarily trained to help people find and access social services; we learn on the job and deal with societal issues along with our patrons. Partnerships are essential to help fill in the gaps, especially with organizations and providers like KHHC members.

# **PRESENTATION: The State of Housing and Homelessness in Kitsap County** - Kirstin Jewell, Kitsap County Housing and Homelessness Division Manager

HH Division responsibilities: strategic planning (Kitsap Homeless Crisis Response and Housing Plan), strategic investment of public funds (~\$6 million annually), gathering data and reporting on results, and coordinating community efforts to end homelessness and increase affordable housing.

What we've learned:

- **183** people experienced homelessness in Kitsap in 2022 (currently compiling 2023 data)
- More emergency housing is needed: in 2022, 1,778 households requested help with housing, including 1,111 households who were literally homeless and 479 households with children.
- 1 in 258 people in Kitsap experienced unsheltered homelessness in 2022. Data shows that the vast majority people are homeless for less than a month.

We learn this through:

- Annual Point-in-Time count (24-hour count of people experiencing homelessness, sheltered and unsheltered). This is a definite undercount, as it only includes who can we find that day that will take the survey
- Homeless Management Information System: documents every person receiving homeless services through public funding; this gathers demographic and programmatic data and allows for sophisticated analysis

Homelessness is an economic problem, compounded by the breakdown of our social systems:


- The cost of housing has increased: rents increased >40% in last 5 years.
- Wages for many are stagnant: minimum wage is \$14.49 vs. 1-bedroom \$26.31. The largest gap is between people on disability/fixed income.
- Not enough affordable AND available housing: 13,875 renter households pay more than 30% of income for housing, often 50%. Statewide we are 120,000+ units behind population growth.
- Once displaced, there are huge barriers to finding housing again.

Intersecting problems cause homelessness: housing shortage, untreated addiction, lack of living wage jobs, chronic physical health issues, not enough shelter/housing assistance, unmanaged mental health issues, fixed incomes, low incomes, domestic violence.

Goals:

- Make homelessness rare, brief, and one-time
- Continuously improve the homeless crisis response system
- Increase community engagement

KHHC members are the backbone of the HH Division's efforts.



Current housing initiatives:

- Increase shelter beds: Added 150 beds during the pandemic; more to be added with the South Kitsap Shelter Project (below)
- Emergency motel program: an additional \$500,000 contracted with KCR
- Increased move-in assistance (first, last, damage deposits) for lowest income households:
   \$350,000 a year, additional \$2 million contracted to KCR

- Kitsap Eviction Prevention Assistance (KEPA) program: spent \$27.5 million on back rent for 3,605 households; wrapping up in early 2023. <u>https://www.kitsapgov.com/hs/Pages/HH-KEPA.aspx</u>
- Foster Youth Independence (FYI) program: housing vouchers and case management for 30 foster youth
- Community investments in affordable housing (CIAH), in development: commissioners approved 1/10<sup>th</sup> sales tax increase dedicated to affordable housing. We anticipate first distribution of funding in 2023 and estimate \$5-6 million annually for affordable housing projects.
- Countywide racial equity and homelessness analysis: action steps include developing a requirement for homeless providers to have racial equity training, racial equity targets for providing assistance, and contracting with "By and For" organizations
- HEART program: current encampment response initiative, addressing encampments on countyowned and managed property. The encampment policy was approved by Commissioners in November 2021. The program includes a full-time coordinator, dedicated encampment outreach team, and emergency motel program (piloted with the Veterans Park closure)

Pacific Building Shelter Project (Mile Hill): the County purchased this former fitness center in 2021. It's currently in the permitting phase and will put out a bid for general contracting soon. They're working with Kitsap Transit to develop a transportation plan. There will be an official public comment period to get feedback from the community.

- 75 guests: families with children, singles, couples
- Pets allowed (facilities are being upgraded to accommodate): co-sheltering model, working with Humane Society to develop
- Residential style: guests qualify and stay a while, no lining up at the door
- 3 meals a day, laundry, showers, stuff storage
- Onsite connection to robust support services: medical, mental health, recovery, job placement, case management, housing stability planning
- Contract with a nonprofit to provide these services: Kitsap Rescue Mission

Questions:

- Housing Trust Fund WA state takes a regional appropriation approach, in which Kitsap is part
  of the Salish region. We want an equitable distribution of this funding across the state but it's
  difficult to compete with other areas with more dedicated grant staff.
- HSC outreach HSC has a new team of 4 outreach staff, working closely with Northwest Hospitality. They go out to connect with homeless individuals where they are.
- HH Division staff available to support with data for agencies Cory Derenburger, <u>cderenbu@Kitsap.gov</u>
- Current funding including supportive housing? Yes, CDBG and Home funding is available to support this
- Are tent cities feasible? At this point there aren't any sanctioned tent cities or safe camp locations in Kitsap. We would need an organization to help sustain and manage it.
