## PRESENTATION: Pallet Homes – Ben Simons: https://palletshelter.com/

Pallet Homes is based in Everett, in business for about 6.5 years. They have built 120 individual rapid, dignified shelter communities, mostly for homeless individuals but also for disaster response and quick workforce housing. They are a public benefit corporation, aiming to end homelessness and provide employment for people with lived experience. They are paid a living wage with benefits and brought on to share their experience.

"Dignity standards": attributes a shelter needs to help people stay long enough to benefit from the pathway towards housing. They can build a full shelter community along with bathrooms within a week and a half. For infrastructure, they just require a land parcel with relatively flat ground and access to utilities. They stockpile units in their manufacturing center in Everett and can send out quickly to work with local contractors.

In Pallet home communities, they haven't seen the negative impacts to local communities that might be present with congregate shelters. Instead, they see drops in crime as well as high rates of people transitioning out of shelter housing into stable housing.

## **Product:**

- The base is a 64 square foot rapid shelter that can be built in about 45 minutes, with all the safety features you would see in permanent shelters.
- There are a variety of insulation and climate control options, meaning they can use them across the county and different climate needs. They typically include 1 bunk, with flexibility for 2.
- They also manufacture larger facilities to be used for families or service offices for providers.
   Bathrooms
- Bathrooms have 2 stall, plus accessible options. They just need to hook up to water, sewer, and power connections. A laundry unit it available as well.
- A larger community room becomes the hub of the community.

All of these facilities are available to see at the Everett Gospel Mission, as well as their manufacturing facility. The site in Longview is managed by the Salvation Army, with an available impact report.

#### Questions:

- Are units wheelchair accessible? Yes, both main structures are easily modified to include a ramp. Accessible bathrooms are available as well.
- Who determines where sites are located? Depends on the community, typically the city or county. They provide the land and contract with a service provider to manage it. It usually includes collaboration with the city/county for zoning. Pallet can help liaise and get quotes.
- What is the cost? Depends: if you want to house 50 people with all facilities, product-wise that's about \$1 million. Site costs are variable depending on the parcel and cost of labor. Pallet can share budget estimates and are happy to work with a general contractor.
- How long do these last? Units are fiberglass reinforced plastic. The oldest community is 6.5 years old, in Tacoma. Based on new material testing, they should last at least 20 years (depending on use). Pallet rarely has to replace large parts like walls. They have a 2-year warranty.

**Sandra Paulino-Winborn, Bremerton CSO DSHS** – DSHS's new intake hours are 8am-2pm, for the foreseeable future (short staff and backlog). The contact center hours are the same.

Once we receive a food stamps application, we date stamp the day we get it and will back date it from that date. If individuals do the intake and are approved, they could be ready that same day (expedited) or first thing next morning. TANF and ABD cash are ready from the date eligibility is approved.

There's been a lot of skimming going on (when card is swiped, tampered readers steal funds from it). Affected individuals can call our contact center and report it to get the card replaced. We can issue cards up to about 4pm depending on the day.
