President's Report - AGM 2025

It is with pride and deep gratitude that I present this President's Report, reflecting on the remarkable progress and growing impact Brad's Place has made since introduction of services in April, 2023.

Since formally launching our services, Brad's Place has welcomed **57 clients** into our recovery programming. Notably, **17 new clients** have joined us since **January 1st, 2025**—a clear indication of the growing need for, and trust in, our work within the community.

Client Growth Over Time: A Testament to Hope and Healing


The graph titled "Client Intake by Quarter" illustrates the steady and inspiring growth in the number of individuals served by Brad's Place since our services were first made available to the community. Beginning with 5 clients in Q2 2023, we've witnessed a consistent upward trend in engagement, reflecting both the increasing need for recovery support in our community and the growing trust in the services we provide.

Each bar represents lives touched—people who bravely stepped forward seeking guidance, compassion, and change. Notably, Q1 2025 marks a significant milestone with 17 new intakes, our highest yet. This surge demonstrates the growing awareness of Brad's Place and the urgent demand for accessible, community-based addiction support.

Behind every data point is a personal journey. This graph is more than numbers—it's a visual reflection of our mission in action and the collective strength of our community to rise, recover, and rebuild.

A bar graph showing client admissions by quarter from Q2 2023 to Q1 2025




Program Outcomes

I am especially proud to share that **11 clients** have completed their personalized recovery program, meeting or exceeding their independent recovery goals. These journeys reflect not only the deep commitment of our team but also the profound resilience of the individuals we serve.

Our commitment to ethical, client-centered care also led us to support **25 clients** in accessing external resources such as residential treatment programs and detox services—ensuring that no one falls through the cracks due to our current program limitations.


Additionally, **5 clients** have chosen to renew their treatment plans at least once, with some working with us for over **18 months**. These long-term engagements reflect a deep trust in the care and stability Brad's Place provides.
