

Renter and any additional drivers must be at least 21 years old

**ID requirements:**

- Valid Driver's License
- Credit card (debit cards not accepted at time of rental)
- Proof of auto insurance or secondary government issued ID

**Not eligible for Intercity Rentals** – Vehicle must return to renting location unless otherwise agreed to in writing by P&C Clayton Enterprise LLC.

**Credit/Debit Cards Credit**

**Qualifications/Requirements:** To qualify to rent the vehicle, the renter must present at the time of rental a current driver's license and valid major credit card in the renter's own name with available credit.

**MILEAGE**

The renter agrees to the miles listed below, exceeding the given mileage per day will result in a \$1.25 per mile fee. Renter is given a total mile limit of 250 PER DAY unless otherwise agreed to in writing by P&C Clayton Enterprise LLC.

**REFUELING POLICY**

The renter agrees to return the vehicle with the same amount of fuel present upon departure. Additionally, the renter agrees to refuel the vehicle with Premium fuel (IF APPLICABLE) and submit a fuel refill receipt at the end of the trip. Failure to complete either one will result in a \$50.00 fee plus additional fees if damage is caused to the vehicle's fuel system.

## **SECURITY DEPOSIT**

At the time of rental, an authorization hold will be secured on the credit provided, to cover the estimated rental charges and any additional charges that may be incurred. These funds will not be available for your use. We may place an authorization amount of up to US\$ 500.00 plus the estimated charges on a customer's card, given certain conditions that will be outlined at time of rental.

Additional authorizations (holds) will be obtained if the vehicle is not returned on the date/time noted on the Rental Agreement or if the original terms of the rental change which result in additional charge.

## **CONDITION OF THE VEHICLE**

The vehicle routinely goes through an Annual safety inspection with a licensed mechanic and to the best of our knowledge and belief that the above-described vehicle is in safe condition and free of any known mechanical and cosmetic defects, unless as given in additional vehicle inspection form. You acknowledge that the vehicle has no damage except what is listed on the inspection form if applicable.

## **RULES OF ACTION**

It is absolutely **PROHIBITED** to use or operate this rented vehicle by anyone not listed on the rental agreement. Each driver must be pre-qualified in person with valid driver's licenses and be a minimum of 21 years of age.

It is absolutely **PROHIBITED** to use or operate this rented vehicle by anyone who is under the influence of alcohol or any narcotics.

It is absolutely **PROHIBITED** to smoke in the rented vehicle. Any evidence of any kind of smoking or any smell of smoke in the vehicle will result in your security deposit being forfeited.

**ALL TICKETS, FINES, FEES** and other (see paragraph 7) received during the rental period, caused as a result of the renter and/or rental period must be paid by the renter in a timely manner.

In case of **LOST, DAMAGED OR LOCKED INSIDE KEYS** requiring key recovery a maximum charge of \$800 may apply.

Damaged **WHEELS/RIMS** are the responsibility of the primary renter.

Rental days are based on **24 hour rental periods**: Please return at the proper time, each hour past the rental will be a \$30 charge for up until the first 30 minutes then anything after will be charged a full day plus tax

**Involuntary rental extensions**: If the renter does not return the vehicle at the end of the rental period it will be considered unauthorized use of a vehicle and will result in the vehicle being reported stolen, the company will pursue you to the fullest extent of the law. Additionally, we have the rights to terminate this agreement at any point and demand the vehicle back.

**No cell phone use while operating the vehicle** unless it is a hands-free device such as a Bluetooth. it is the law; the driver is prohibited from handling any electronic device while driving regardless of the behavior of use.

Renter agrees to take **full responsibility for any damage** to vehicle.

In the event the renter causes damage that exceeds (1) day to repair, **the renter agrees to pay an additional \$100 for every day** after that the vehicle is being repaired.

Renter agrees and understands that tire treads will be recorded prior to departure, any excess loss of tire tread as a result to events such as burnouts, donuts etc will be subjected to **\$500 deducted from the security deposit**.

The rented vehicle is **NOT to leave the United States of America**, failure to comply will result in the vehicle being reported stolen along with the deposit being kept and any other necessary charges to the renter's credit card to return the vehicle
