Cancellation/Refund Policy

You may cancel your order at any time before work has begun on your quilt top. Once work has begun (the quilt is loaded on the frame for quilting) the order can be cancelled but a minimum \$60 fee will apply to compensate Pretty Kitty Quilts for the labor included in preparing the quilt. Client must pay return shipping or arrange to pick up the quilt. If quilting is at least 50% complete, the full price quoted to the client in the estimate invoice agreed upon before beginning applies.

Payment Policy

Payment is due upon completion of the services agreed upon during the estimate phase, and includes return shipping unless a shipping promotion applies. The completed quilt will not be returned to the client until payment has been received by Pretty Kitty Quilts. Payment is accepted via cash, personal cheque, money order, PayPal, or Venmo. Cheques and money orders must be made payable to Pretty Kitty Quilts. A \$30 fee applies to all returned cheques. If payment in full is not received within 90 days of quilt completion and no good faith efforts have been made to furnish payment, the quilt will be considered the property of Pretty Kitty Quilts according to Washington State law regarding abandoned property.

The arbitrator's award shall be final, and judgment may be entered upon it in any court having jurisdiction. In the event that any legal or equitable action, proceeding or arbitration arises out of or concerns these Terms and Conditions, the prevailing party shall be entitled to recover its costs and reasonable attorney's fees. The parties agree to arbitrate all disputes and claims in regards to these Terms and Conditions or any disputes arising as a result of these Terms and Conditions, whether directly or indirectly, including Tort claims that are a result of these Terms and Conditions. The parties agree that the Federal Arbitration Act governs the interpretation and enforcement of this provision. The entire dispute, including the scope and enforceability of this arbitration provision shall be determined by the Arbitrator. This arbitration provision shall survive the termination of these Terms and Conditions.

Class Action Waiver

Any arbitration under these Terms and Conditions will take place on an individual basis; class arbitrations and class/representative/collective actions are not permitted. **THE PARTIES AGREE THAT A PARTY MAY BRING CLAIMS AGAINST THE OTHER ONLY IN EACH'S INDIVIDUAL CAPACITY, AND NOT AS A PLAINTIFF OR CLASS MEMBER IN ANY PUTATIVE CLASS, COLLECTIVE AND/ OR REPRESENTATIVE PROCEEDING, SUCH AS IN THE FORM OF A PRIVATE ATTORNEY GENERAL ACTION AGAINST THE OTHER.** Further, unless both you and Pretty Kitty Quilts agree otherwise, the arbitrator may not

consolidate more than one person's claims, and may not otherwise preside over any form of a representative or class proceeding.
