Subj: Minutes of Detachment Meeting on 16 January 2021

1. Meeting was opened at 0745 hours with the following Marines in attendance: Bob Jonson, Perry Caldwell, John Reichman, Rusty Alums, Ron Russell, Ed Whealdon, and Earl Allen.
2. Officers absent: Jr. Vice Cmdt., Judge Advocate, Adjutant and Paymaster, and Webmaster.
3. Sickness and welfare: Larry Morgan is now a resident of an undisclosed Alabama VA facility. Jean Weidner is receiving Hospice care at her residence, Morningside Retirement Facility.
4. Membership applications: None
5. Financial report: Our income since October, 2020 is \$1,265.00. Our expenses for the same period are \$1,144.94. Our bank balance is \$9,356.89. Since October we have received donations of #580.00
6. Old Business
 - A. Raffle: \$23.00 won by Bob Jonson, donated to the detachment.
 - B. Covid19 vaccinations: 1) EAMC: (334) 528-8222 2) Thomas Pharmacy: (334) 745-3632. At this time, only those 75 years old or older are eligible to receive the vaccination.
 - C. Toys for Tots: Rusty Alums and Ricardo Garcia worked with the Lee County Sheriffs Department, culminating in giving toys to 174 children. Our detachment donated \$300.00 in this effort to assist in purchasing toys.
7. New Business
 - A. Elections: Although our detachment bylaws stipulate yearly elections, recently, our tradition has been to invite officers who were elected the previous year to extend for another year. All officers canvassed at today's meeting have agreed to serve another year.
 - B. Recruiting: A newspaper article describing our organization and meeting particulars is being finalized to be submitted for publication in both the O/A News and Opelika Observer.
 - C. Social: After discussion about having a social at Venditoris Restaurant in February, it was decided, for Covid19 considerations, to table this discussion until our next meeting.

- D. Donations: The commandant opined that since our detachment is likely too long in the tooth to make our operating money from hosting another annual Alabama Department meeting, he encouraged members to make monthly donations to our operating budget, as they are able.
