AGREEMENT

This agreement is between JEREMY HAMEL (hereafter referred to as 'JH') and 'The Client' as specified below. Upon acceptance of this agreement, JH agrees to perform at the date, time and place specified. JH will furnish an adequate sound package, a selection of recorded music, appropriate effects lighting, and a wireless microphone at the time and location specified.

TERMS

*****Please initial after all of the following terms stating your agreement to each term.*****

a. Parties obligations under this Agreement are subject to force majeure. Force majeure includes acts of God, war, natural disaster, government regulations, strikes, pandemics, walkouts or other labor disturbance, order of any government agency, court or regulatory body having jurisdiction, public health scares, shortages, blockade, embargo, riot, civil disorder, transportation interruption, terrorism, unavailability of the venue selected as site for the event, and other such conditions beyond the reasonable control of the parties herein, making it legally inadvisable, illegal, impracticable, or impossible for JH to perform his obligations under this Agreement. _____

b. To ensure that the performance begins on time, The Client is requested to: (1) designate an area at least 6 feet x 6 feet for the performance; (2) locate the nearest 110 volt AC outlet and check its operation; (3) arrange to have one reasonably strong table, 2 feet x 6 feet or larger, **with the appropriate table covering** for exclusive JH use. _____

c. To prevent injury to event attendees, JH reserves the right to deny access to equipment owned, leased, or being used exclusively by JH. If JH feels a hazardous situation arising, it is the responsibility of The Client, upon notification, to take action and remedy the situation. If no action is taken, JH may, in extreme instances, delay the performance. As a last resort, if bodily or material harm seems imminent, JH will shut down and cancel the performance. JH assumes no liability for injuries to The Client and/or guests unless injury is directly the fault of JH. _____

d. In the event that JH is unable to perform during the entire agreed upon time period, due to no fault of JH, compensation is limited to: (1) time equal to the time lacking or (2) a refund of one-hundred dollars per half hour that JH could not perform. Except when the performance is incomplete due to the fault of JH, The Client is expected to pay the Total Rate. _____

e. JH encourages The Client to request specific song selections for play during this performance and submit music requests at least one week prior to the performance date. JH will make every effort to play all requests but cannot be held responsible if specific selections are not played due to lack of availability or appeal. Unless otherwise specified by The Client, remaining music will be based on popularity, danceability, and demographic appeal, at the discretion of JH. _____

f. The rate for this service includes a deposit of 50% of the Total Rate. This contract is null and void if The Client fails to submit the required funds within 10 days of signing this agreement. The deposit is non-refundable if the event is canceled by The Client for any reason except official military mobilization orders and/or conditions listed in *Term a*. The balance of the Total Rate, less deposit amount, is due prior to the Event Date. _____

g. At his discretion, JH reserves the right to employ one assistant as either content creator, disc jockey, emcee, or audio technician while in the performance of his contractual duties. _____

h. Risk of exposure to COVID-19 exists in any public place where people are present. By hosting this event The Client voluntarily assumes all risks related to exposure to COVID-19. _____
