This letter will serve to introduce \_\_\_\_\_ who is an INDEPENDENT CONTRACTOR and obtains Discount cards through Working Towards A Better Future Inc.

Your son / daughter is being given an opportunity to work as an INDEPENDENT CONTRACTOR or "Little Merchant" and, as such, to solicit Discount Cards. The above-named Crew Dealer agrees to pay a commission for each discount card sold by your son / daughter at the rate of \$6.00-\$8.00 per discount card sold.

Our workweek starts on MONDAY and ends on SATURDAY. Each salesperson is paid for each week's sales on SATURDAY OF THE SAME WEEK FOR EACH DISCOUNT CARD SOLD, UNLESS SATURDAY IS NOT WORKED THEN ON THE FOLLOWING WORK DAY. Your child may be paid by CHECK or CASH for what they sell. Being paid by a weekly commission check is a good way for them to keep an accurate accounting of monies they have earned. SHOULD THEY EVER NOT RECEIVE A CHECK ON SATURDAY OR ON THE FOLLOWING WORK DAY, OR THE AMOUNT SEEMS TO BE INCORRECT, PLEASE CALL ONE OF THE NUMBERS LISTED ON THIS FORM!

Your son / daughter will be working as an INDEPENDENT BUSINESSPERSON and, as such, will be paid for PRODUCTS (Discount Cards) sold. Most youths and their parents find this experience a very rewarding one. It is an opportunity to make very good earnings, to learn the value of work, to manage his / her own money, and as an independent businessperson they learn the benefits of managing their own time, self discipline, and being rewarded according to their efforts and results. Being independent, they may work when and how they wish. The DISCOUNT CARDS have some restrictions as to what areas/cities they correspond to and can be solicited and I can advise them of these areas and restrictions. I may make transportation available to enable your son / daughter to solicit in other areas to increase their earnings and to point out any restricted areas in the neighborhoods worked. Although the youths are not required to work any specific days, if a reasonable amount of sales are not produced on a fairly consistent basis, this agreement may have to be terminated due to the unproductive effort and limit on space available. Also, I may decide to not make transportation available to any youth that does not work on a consistent basis because of the hardship involved to drive out of my way.

Working Towards A Better Future is an after school, part time job opportunity program for teens and young adults to work in a productive team-oriented environment that helps build confidence, social skills, and leadership skills which are essential in today's job market. We AIM to give a competitive rewarding experience while financially empowering teens, young adults, and their families.
