An Unincorporated Private Members Association established under Common Law

1. Preamble

This Certification of Execution confirms the lawful establishment and commencement of the Grey Mouse Debt Assist Private Members Association, hereinafter referred to as “the Association,” “PMA,” “Club” or “Debt Assist PMA”.

This Association is created by mutual agreement and free association of the undersigned founding member(s), acting in their private capacity, to unite in pursuit of the lawful and beneficial purposes set out in the Association’s Charter and Articles of Association.

2. Legal Basis

This Association is founded under the common law right to freedom of association and operates as a private, unincorporated members’ body.

It exists outside the framework of corporate or statutory incorporation and functions solely through the mutual consent of its members.

The Association is not a company, partnership, or public body. It does not conduct corporate business nor does it provide regulated financial or legal advice or services.

3. Governing Instruments

The following documents constitute the lawful foundation of the Association:

1. The Charter of the Grey Mouse Debt Assist Private Members Association, adopted on 15th April 2026 and
2. The Articles of Association of the Grey Mouse Debt Assist Private Members Association, adopted on 16th April 2026

These documents together define the Association’s:

- Purpose and objectives;
- Membership structure;
- Governance and accountability mechanisms;
- Lawful powers and duties;
- Principles of conduct, confidentiality, and mutual aid.

Each signatory below affirms that they have read, understood, and agreed to these governing instruments in full.

4. Founding Declaration

By signing this Certification, the founding member(s) hereby:

- a. Declare the formal establishment of the Grey Mouse Debt Assist Private Members Association as a lawful, unincorporated association operating in the private domain under common law;
- b. Adopt and ratify the Charter and Articles of Association as binding upon all members;
- c. Authorise the first Committee, comprising of the founding member(s), to administer the Association's affairs in accordance with those documents;
- d. Confirm that all operations and activities shall be conducted solely for the lawful, educational, and mutual benefit of the members; and
- e. Agree that membership is a private relationship of trust and mutual cooperation, and not a commercial engagement.

5. Law and Jurisdiction

This Certification and all instruments of the Association shall be interpreted according to the law of England and Wales, in harmony with the principles of fairness, equity, and good faith under common law.
