

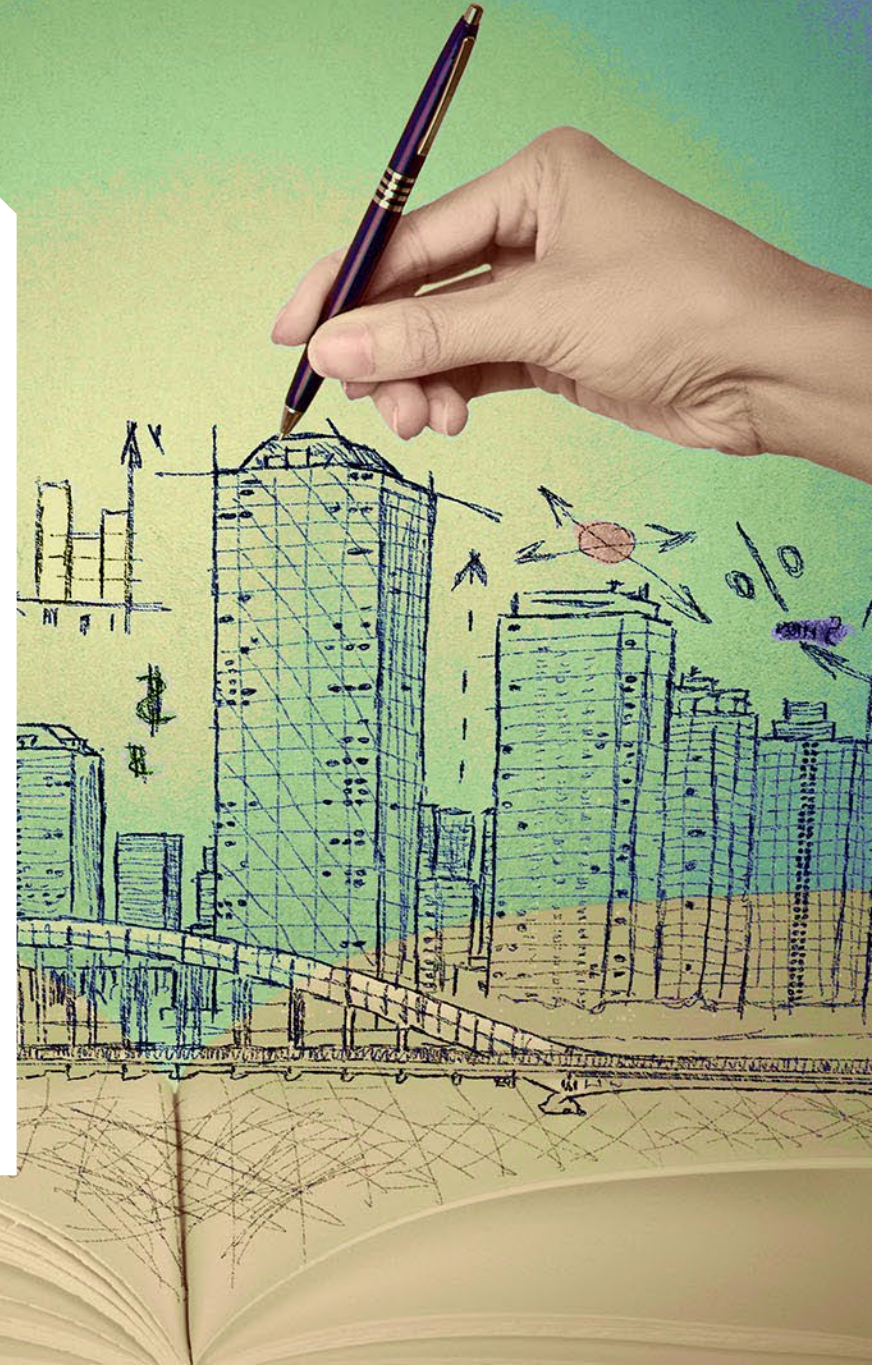

Recreational, social, supportive, or health-related activities.

Construction and renovation activities.

Fees related to legal or administrative actions.

Individual assistance in accessing housing.

Activities not supporting the priority areas.

Expenses for activities carried out prior to the Centre's written approval of funding.

Activities that are not new or transformative to the organization, provider or sector.

Core programs, regular services, administrative and operating expenses.

Retainer fees for work to be completed in the future.

Fundraising, capital investment and research* activities.

OUR GRANTS



>>>> COMMUNITY-BASED TENANT INITIATIVE (CBTI)

Intent

- Turning tenants from customers or service recipients into active participants in the housing world.
- Organize tenants to:
 - develop or advocate for more and better community housing,
 - participate in governance and in developing housing programs,
 - inform new policies that take residents' needs, hopes and rights into consideration.

Objectives

- Increase/promote access to information;
- Build capacity around housing decisions and responsibilities;
- Increase participation in housing-related decisions and projects.

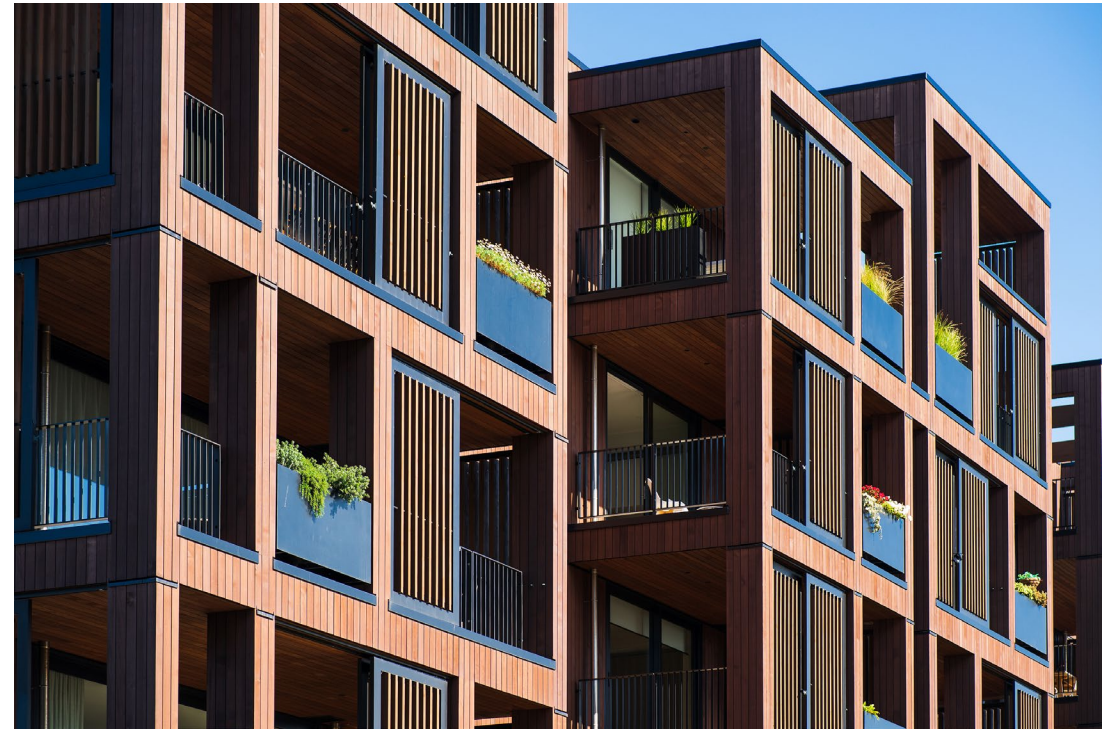
