RULES/REGULATIONS

- Residents will be required to keep their living quarters clean and neat at all times – i.e. beds **MUST** be made, no clutter or excess trash.
- Upon your arrival at CDH, you will be assigned an area to clean, in addition to your room. Your area will be inspected **DAILY** by the Resident Manager.
- Social visits are allowed between 10 am and 8 pm. No guests are allowed in the bedrooms. Residents and guests may utilize all other areas of the residence.
- All visitors to the house must be approved by the Resident Manager. Guests must send an email to contact@cedricdean.com. If a visitor has a criminal conviction, he/she will not be allowed to visit the house, unless approved by your probation officer.
- Transportation privileges while at CDH **MUST** be authorized by the **RESIDENT MANAGER**. If allowed to drive the house vehicle, you must have a valid driver's license and proof of **NON OWNER AUTO** insurance.
- Do not engage in any sexual relationships at the house. (MAJOR VIOLATION)
- Do not discuss your case with any resident or staff.
- Other residents at the house are at the house for a variety of reasons. Residents may be under home confinement. The rules that apply to other residents may not apply to you. Your goals while at the house are set by your supervised release officer and case manager. Your activities must be approved and monitored by both authorities.
- If you have any questions and/or concerns regarding the house, notify the resident manager immediately.

- If you are on home confinement, anytime you want to leave the house, you need to submit a request to your supervised release officer outlining the date and time of the event, address and phone number of the place you wish to go, and the times you are leaving and returning. For federal home confinement residents, all requests must be submitted 72 hours in advance of the pass date. (MAJOR VIOLATION)
- Residents are expected to be employed full time and/or exempted by the ADA upon admission to the house, unless otherwise directed by your supervision officer or the Court. Failure to do so may place you in violation of the transitional house program. (MAJOR VIOLATION)
- All residents must participate in CDH transitional classes.
- Curfew at the house is 11:00 p.m. The only exception to this is for employment and pre-approved treatment (NA/AA meetings are excluded). (MAJOR VIOLATION)
- You are responsible for your own food, supplies, and toiletries. The HOUSE DRIVER will be authorized to make weekly trips for residents to food pantries.
- Free WiFi is provided. CDH TVs and Computers are not to be used to access ANY FORM OF PORNOGRAPHY. (MAJOR VIOLATION)
- Smoking is prohibited inside the house. Cigarettes, cigars, chewing tobacco, rolling papers, loose tobacco, e-cigarettes, and lighters may be used outside the house. (MAJOR VIOLATION)
- Dishes must be washed after usage.

NOTE: MAJOR VIOLATIONS OF CDH RULES AND REGULATIONS MAY RESULT IN IMMEDIATE TERMINATION FROM THE PROGRAM. MINOR VIOLATIONS WILL RESULT IN A \$100 FINE PER VIOLATION.
